Dear Clerk:

Pursuant to Supreme Court Rule 30.4, I write to apply for a thirty-day extension of time, from June 25, 2018, to July 25, 2018, for the Quileute Indian Tribe and Quinault Indian Nation to file their Brief in Opposition to the Petition for a Writ of Certiorari filed on May 21, 2018. Neither tribe has previously requested an extension of time in this matter.

The specific reasons for this application are to permit the two tribes, their attorneys and tribal councils adequate time to evaluate whether to file a Brief in Opposition and to coordinate their positions with the objective of filing a single Brief in Opposition in the event they file one; and to permit the tribes to review any briefs supporting the Petition, which are due on June 25, 2018.
