Dear Mr. Bickell:

On January 16, 2018, this Court granted the Joint Emergency Motion to Defer Consideration of Petition for a Writ of Certiorari, pending the district court's approval of the proposed settlement. On January 29, 2018, the United States Court of Appeals for the Second Circuit granted the parties' joint emergency motion for limited remand to the district court to seek preliminary and final approval of a negotiated class settlement between plaintiffs-appellees and defendant-appellants. Since that time, the district court has conducted settlement approval proceedings and the petition for certiorari in the above-captioned case remains pending.

We write to inform the Court that on June 28, 2018, the United States District Court for the Southern District of New York granted final approval of the settlement in the above-captioned case, No. 14-cv-9662 (S.D.N.Y.), and entered judgment approving the settlement. By the parties' calculations, the time to appeal runs on July 30, 2018. The parties will inform this Court after the time to appeal has run, in which case, assuming that there are no appeals, the parties will move to dismiss the petition for writ of certiorari.
