By letter of June 28, 2018, we wrote that the district court had approved the settlement in the above-captioned case and committed to inform the Court if any appeals as to the settlement were filed. We now inform the Court that between July 16, 2018, and July 31, 2018, three sets of objectors filed notices of appeal of the district court's decision approving the settlement. We understand that two of the objectors are seeking to vacate approval of the settlement. (The other objector and class counsel have filed appeals only with respect to the district court's fee award.) If any of the now-pending appeals results in vacatur of the settlement's approval, the parties will return to their respective positions prior to the settlement

agreement. If the appeals are rejected, the parties will then move to dismiss the petition for certiorari.
