MEMORANDUM FOR THE UNITED STATES

Petitioner contends (Pet. 7-21) that his prior conviction for armed robbery, in violation of Fla. Stat. § 812.13 (1989), was not a conviction for a "violent felony" under the elements clause of the Armed Career Criminal Act of 1984, 18 U.S.C. 924(e)(2)(B)(i). The Court is currently considering a related question in <u>Stokeling</u> v. <u>United States</u>, cert. granted, No. 17-5554 (Apr. 2, 2018). The petition for a writ of certiorari should therefore be held pending the Court's decision in <u>Stokeling</u> and then disposed of as appropriate in light of that decision.*
