**APPLICATION FOR EXTENSION OF TIME TO FILE
A PETITION FOR WRIT OF CERTIORARI**

**To the Honorable Clarence Thomas, as Circuit Justice for the United States
Court of Appeals for the Eleventh Circuit:**

Petitioner/Applicant, Pamela Timbes, respectfully requests that the time to file her Petition for Writ of Certiorari be extended sixty days. The Eleventh Circuit Court of Appeals decision was filed on September 6, 2017, Exhibit A-**App. A**. Decisions denying Timbes' Petitions for Rehearing and Rehearing En Banc were filed on November 28, 2017, Exhibit A-**App. B** and Exhibit A-**App. C**. Absent an extension of time, the Petition for Writ of Certiorari is due on February 26, 2018. This application is being filed more than ten days prior to that due date. Decisions are attached as noted above. *See* S. Ct. R. 13.5. This Court would have jurisdiction over the judgment under 28 U.S.C. Section 1254.

BACKGROUND

Application for Stay Pending Certiorari was submitted to this Court on January 2, 2018; however, the Application was returned because it had to be first submitted to the Eleventh Circuit Court of Appeals. The Application for Stay was subsequently submitted the Eleventh Circuit, Case No 17-10556; however, it has not yet been ruled upon. The Application for Stay Pending Certiorari, **Exhibit A**, submitted originally to this Court, is attached to provide background information and will be resubmitted to this Court if the Eleventh Circuit Court denies the stay.

REASONS FOR GRANTING AN EXTENSION OF TIME

Pamela Timbes, *pro se*, is employed full time and is the care giver for her two elderly parents, both of whom are currently ill with the flu. Timbes needs an extension of time to prepare her Petition for Writ of Certiorari. **Exhibit A** sets forth a reasonable probability that a Petition for Writ of Certiorari would be granted by this Court; thereby justifying the extension of time to submit the Petition, especially under the present circumstances.

CONCLUSION

For the foregoing reasons, the time to file a Petition for Writ of Certiorari in this matter should be extended sixty days to and including April 27, 2018.
