

Other Comments (if any): The client Ms. Epps stated that Mr. Adkins requested a statement as to the date of this filing on January 24, 2019. The client has been operating under an assumption that the petition for writ of extraordinary writ does not have exact date requirements. We had initially filed this petition November 2018. Client communicated that redactions were required, but we did not rec'y any specifics until last week. Because this client is not technologically advanced, she did not email comments; instead, she mailed us a box of books with markups for redactions to our office on January 14, 2019. These client markups needed to go through edits and client proof approvals. We need this approval before we run the press. However, this client is not email-proficient and cannot take calls at work, so these proof turns took time to turn around with client comment. In addition, we asked for a copy of a clerk's letter with any date requirement (e.g. a 30 or 60 day letter) and did not receive one. Thus, we are in the dark as to what if any timing requirement exists on this filing.
