Dear Mr. Harris:

On behalf of Respondents, Sault Ste. Marie Tribe of Chippewa Indians and Kewadin Casinos Gaming Authority, I request a thirty-day extension of time to and including May 20, 2019 to file a brief in opposition to the above-referenced Petition for a Writ of Certiorari. *See* Sup. Ct. R. 30.4. Petitioner Buchwald Capital Advisors LLC does not oppose this request.

On March 18, 2019, Petitioner filed its Petition for Writ of Certiorari. The Petition was docketed on March 20, 2019. Pursuant to Rule 15.3 of the Rules of the Supreme Court, Respondents must file their brief in opposition by April 19, 2019 unless the time for filing is extended. A thirty-day extension would result in a deadline of Monday, May 20, 2019, because the last day of the extended period would otherwise fall on a weekend.

There is good cause for this extension because the Respondents' lead counsel in this litigation retired on February 1, 2019, shortly before the United States Court of Appeals for the Sixth Circuit rendered its opinion and judgment in this case. Counsel representing the Respondents in this Court therefore will need additional time to become familiar with the litigation, research the issues, and prepare the opposition to the Petition.
