Dear Mr. Harris:

Pursuant to United States Supreme Court Rule 30(4), Respondent the State of Arizona respectfully requests a first, 60-day extension of time to file the Brief in Opposition to Petitioner Leeman's Petition for Writ of Certiorari, which is currently due on May 30, 2019. Respondent requests an extension of time to and including July 29, 2019.

The requested extension is no longer than the extension that Petitioner successfully requested and is necessitated by undersigned counsel's involvement in other pending state and federal cases and the fact that counsel was only recently assigned to this case and is not yet familiar with the record. With respect to her recent and pending caseload, counsel filed an answering brief on direct appeal in state court this past Friday, May 17, 2019 (*State v. S. Anaya*, No. 2 CA-CR 2018-0225); will be filing an answering brief in a first-degree murder case in state court tomorrow, May 21 (*State v. X. Anaya*, No. 2 CA-CR 2018-0300); has four additional state answering briefs due by June 12 (*State v. C. Carter*, No. 2 CA-CR 2018-0157; *State v. Lyme*, No. 2 CA-CR 2018-0234; *State v. Healer*, No. 2 CA-CR 2018-0134; *State v. B. Carter*, CR-18-0508-PR); and has a 13-issue federal-habeas-corpus answering brief due by July 5 (*Gibson v. Ryan*, CIV-19-08032-PCT). Moreover, counsel will almost certainly need to extend the current due dates of two or more of those cases in light of the total caseload and her substantial supervisory and brief-reviewing duties.




