Dear Mr. Harris:

We represent Respondent Estate of Adriano Roman, Jr. in the above petition. Please enter our appearance and accept this letter as Respondent's request for a 30-day extension of time to file a brief in opposition to the petition pursuant to Supreme Court Rule 30.4. The opposition is currently due May 31, 2019; we request a new due date of July 1, 2019.

The reason for the requested extension is my competing briefing commitments in May and early June 2019, which are as follows:

- Merits brief at the New Jersey Appellate Division in 160 West v. Amma Corp. et al., A-2454-18 (NJ App. Div. 2019), which will consist of an at least 50-page brief and an approximately 4,000-page appendix, and which is due June 1, 2019.

- Merits brief at the Third Circuit in Richardson v. Coverall North America, 18-3393 (3d Cir. 2018), which is due May 28, 2019.
- Hearing on May 16, 2019 and post-hearing briefing in New Jersey Superior Court in Askoys v. Edgewater Lofts LLC, et al., BER-L-3452-16 (NJ Law Div. 2016).
- Opposition to an order to show cause in New Jersey Superior Court in Bozzi v. Paramus, BER-L-2834-19 (NJ Law Div. 2019), which is due May 17, 2019.

In addition, we are partnering with the Northwestern University Pritzker School of Law's Appellate Litigation Clinic on this opposition. A 30-day extension allows the students working on this petition to fully familiarize themselves with the record.

Accordingly, we respectfully request a 30-day extension of time to file the brief in opposition to July 1, 2019.
