STROUD, Judge.

On 21 October 2016, petitioner filed a petition for a contested case hearing in the Office of Administrative Hearings ("OAH"), alleging that a 28 October 2015 written warning for unacceptable personal conduct due to attendance issues was arbitrary and capricious and thus his rights to due process and equal protection under the Fifth and Fourteenth Amendments to the United States Constitution were violated. Respondents filed a motion to dismiss on the grounds that OAH lacked jurisdiction over the matter; petitioner failed to state a claim upon which relief can be granted; petitioner failed to properly serve respondent; and OAH could not exercise personal jurisdiction over respondent. OAH entered a final decision on or about 14 December 2016 dismissing the case with prejudice finding that it lacked subject matter jurisdiction. Petitioner purports to appeal from the final decision.

We must dismiss petitioner's appeal because the record before us is insufficient to vest our Court with jurisdiction to consider the appeal as petitioner failed to file a notice of appeal. *See Brooks, Com'r of Labor v. Goodell*, 69 N.C. App. 701, 707, 318 S.E.2d 348, 352 (1984) ("Without proper notice of appeal, this Court acquires no jurisdiction."). Without a notice of appeal,

this Court has no jurisdiction to review petitioner's appeal. *See id.* This appeal is dismissed.

DISMISSED.

### **FINAL DECISION ORDER OF DISMISSAL**

THIS MATTER is before the honorable Donald W. Overby, Administrative Law Judge presiding, for consideration of Respondent's Motion to Dismiss filed with the Office of Administrative Hearing ("OAH") on December 1, 2016, as well as Petitioner's response thereto filed with OAH on December 12, 2016. Having

considered the respective filings of the parties and matters of record proper for consideration, the undersigned finds as follows:

Petitioner's contested case petition avers, among other things, potential violations of the 5th and 14th Amendments to the United States Constitution. The Office of Administrative Hearings is an agency created by statute and only has those powers and authority as granted specifically by statute.

By its creation, OAH provides the procedural due process for matters within its jurisdiction. In as much as Petitioner's contentions raised in the contested case petition center on a written warning, the central question then is whether or not OAH has jurisdiction over such matters, to which the answer is no. N. C. Gen. Stat. §126-34.02 is the State Human Resources Act, and it specifically enumerates personnel matters which may be brought before the OAH, and matters alleged herein are not covered. Therefore, OAH lacks subject matter jurisdiction. Petitioner recites often in his response reference to the State Personnel Manual and therein lies his recourse, if any, to his concerns with the written warning.

Now, therefore, this matter is properly before this Tribunal for consideration, and dismissal is appropriate under the facts and circumstances of this contested case. Thus, it is hereby ORDERED that this matter is DISMISSED with prejudice.

#### **NOTICE AND ORDER**

This Final Decision is issued under the authority of N.C.G.S. § 150B-34. Pursuant to N.C.G.S. § 126-34.02, any party wishing to appeal the Final Decision of the Administrative Law Judge may commence such appeal by filing a Notice of Appeal with the North Carolina Court of Appeals as provided in N.C.G.S. 7A-29(a).

The appeal must be filed within 30 days of receipt of this Final Decision. The notice of appeal must also be filed with the Office of Administrative Hearings, and served on all parties to the contested case hearing.
