Dear Mr. Harris:

The Court docketed the petition in the above-referenced case on May 15, 2019 and requested a response on July 18, 2019. The briefs in opposition are due August 19, 2019. Pursuant to Supreme Court Rules 15.3 and 30.4, Respondents Coventry Health and Life Insurance Company and Kentucky Cabinet for Health and Family Services each respectfully request an extension until September 19, 2019, to file their briefs in opposition.

Coventry Health and Life Insurance Company recently retained Williams & Connolly as its representative in the Supreme Court. I will be serving as counsel of record. Medley Opportunity Fund II, LP, et al.*, No. 19-2082 (3d Cir.), due on September 9, 2019.

Respondent Kentucky Cabinet for Health and Family Services is represented by Matthew Franklin Kuhn of the Kentucky Office of the Governor. Mr. Kuhn has several proximate deadlines
