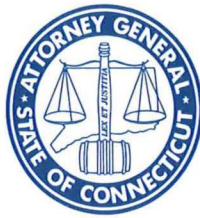

Dear Attorney Harris:

I represent the Defendants-Respondents, Secretary of the State Denise Merrill, State Treasurer Denise Nappier, and State Comptroller Kevin Lembo (collectively, "State Respondents"), in the above captioned case. Pursuant to Rule 30.4 of the Rules of the United States Supreme Court, the State Respondents hereby request a thirty day extension of time, up to and including July 24, 2019, in which to file their response to the petition for certiorari. The petition was docketed on May 24, 2019, and the State Respondents' brief in opposition currently is due by June 24, 2019. The undersigned has contacted counsel for the Petitioner, Proloy K. Das, to obtain his position on the requested extension, but has not received a response. Counsel for Respondent Phillip Young, Attorney William M. Bloss, consents to this request.


