Appendix C

CONSTITUTIONAL AND STATUTORY
PROVISIONS

United States Constitution

Article VI

“This Constitution, and Laws of the United States which shall be made in Pursuance thereof; and all Treaties made, or which shall be made under the Authority of the United States, shall be supreme Law of the Land; and the Judges in every State shall be bound thereby, any Thing in the Constitution or Laws of any State to the Contrary notwithstanding.”

Amendment XIV, Section 1:

“All person born or naturalized in the United State, and subject to the jurisdiction thereof, are citizens of the United State and of the state wherein they reside. No state shall make or enforce any law which

shall abridge the privilege or immunities of citizens of the United State deprive any person of life, liberty, or property, without due process of the law; nor deny to any person within its jurisdiction the equal protection of the laws.”

18 United States Code § 371

§371 Conspiracy to commit offense or defraud United States

“If two or more persons conspire either to commit any offense against the United States, or to defraud the United States or any agency thereof in any manner or for any purpose, and one or more of such persons do any act to effect the object of the conspiracy, each shall be fined under the title or imprisoned not more than five years, or both.
