CONSTITUTIONAL AND STATUTORY PROVISIONS INVOLVED

STATEMENT OF THE CASE

当地时间本周四 (2017.2.2) 早晨, 美国总统特朗普出席他上任以来的第一个全美年度祷告早餐 (National Prayer Breakfast)。面对众多国会议员、外国政要和宗教信仰领袖, 他发表了大约 20 分钟的演讲。主题围绕美国核心的基督教信仰价值观, 结合自己亲身的信仰经历、国内外严重的信仰逼迫局势, 鼓励大家重树信心。

他强调自己的政府和内阁会寻求上帝的心意来服事民众, 致力于建立一个上帝之下 (Under God) 的美丽国家。

全美祷告早餐会每年二月的第一个星期四举行, 是美国的政治传统之一, 由美国前总统艾森豪威尔在 64 年前开始的, 在这个聚会中见证过无数信仰的力量。

特朗普首先感谢了许多人, 包括国会议员和来自全球各地的信仰领袖。

他着重介绍了才宣誓就职的美国新任国务卿 Rex Tillerson (曾任埃克森美孚石油公司 CEO) 特朗普认为他将出色的完成这个工作。

从丹佛的空军基地回来，在那里见到了高级军士长 William Ryan Owens 的家人，当时这位为国捐躯的英雄被运了回来。

非常让人难过，但又让人难忘，他的家人在那里。他的家人真的很棒，非常爱他，为此深受打击。葬礼仪式非常感人，他为了保卫我们的国家而牺牲。他献上自己的生命为了保护我们同胞的生命，我们欠下他及家人永恒的情义。“人为朋友舍命，人的爱心没有比这个大的。”（约翰福音 15:13）

一代又一代保护我们的军人让我们的自由得以延续，我们的自由是用他们的牺牲赢得的。我们的安全是他们用汗水、鲜血和泪水挣来的。上帝祝福这片土地，赐给我们这些勇敢的英雄和爱国者，他们非常非常珍贵，我们要好好照顾他们。

3.真正的成功是什么？

我们的军人们明白，重要的不是党派或意识形态或教义。将我们所有人联结为一体的忠诚纽带，是我们的信仰。美国是一个基督徒的国度，遍布全国的各城各镇。我们很轻易就能发现我们轻易遗忘掉的东西，决定我们生命质量的不是物质上的成功，而是属灵生命成功。

我想告诉你们的是，我认识很多物质上非常成功的人。他们是物质上成功的人，可是他们中有很多人非常痛苦，根本没有幸福。

我也认识很多没有物质成就的人，可是他们却有一个很棒的家庭、很好的信仰。他们没有钱，至少不能与我们中许多人相提并论。可是，他们却满有喜乐，对我来说，这些人才是真正的成功者。

整个世界正处在麻烦之中，我们要将这些麻烦摆平，好吗？这就是我干的事。

当你听到说我在电话中与人发生了不快，不要担心。我们必须刚强壮胆，世界上几乎所有国家都在从我们这里获利，这些事将不会再发生了。

我们已经看到无法想象的暴力事件，并且是以宗教的名义进行的。这样肆无忌惮的暴力并不是少数，所造成的恐怖景象无法描述。

恐怖主义是对宗教自由严重的威胁，它必须被制止，而且一定会被遏制，也许某段时间可能看起来不那么顺利，可它还是会被终结。

顺便说一句，你们知道“疯狗”将军，我不该这样称呼他。

James Mattis 将军，人们称呼他为“疯狗”是有原因的，他从未输过一场战争。总是能赢，而且快速制胜。他是我们的新任国防部长，将与国务卿 Rex 一起合作他现在在韩国，然后去日本和其它地方。我告诉你们，我已经非常了解他。他真的不错，我们有一个真正了不起的将军为我们工作，这是我们所需要的。所以请你们拭目以待吧。

我们看到热爱和平的穆斯林，被伊斯兰国的杀人狂虐待、迫害、屠杀和压迫。我们看到有人威胁要灭绝犹太人，我们看到伊斯兰国针对基督徒的灭绝行动，他们将基督徒的头砍掉。

自从中世纪之后，我们看到过这种事吗？我们从未看到这种砍头的事，现在他们就直接砍头，他们在铁笼子中将人淹死。所有国家都有道德上的义务去声明反对此种暴力，所有国家

美国将会获得成功，只要我们脆弱的那些公民，我们有些公民非常脆弱，有一条通往成功之路。

美国将会兴旺发达，只要我们都有信心，彼此之间有信心，还有对上帝的信心。

这种对上帝的信心，曾经激励了无数男女们帮助有需要的人们，到海外的战场驻扎，放下家中的武器。为这片土地上每个男人、女人和孩子争取平等的权利。

让朝圣者们远渡重洋的是这个信仰，让拓荒先驱越过大平原的是这个信仰，让美国各地的年轻人追逐梦想的也是这个信仰。他们正在追逐自己的梦想，我们要把他们的梦想拿回来。

只要我们有上帝，我们就永远都不会孤独。无论是夜间看守警卫的士兵，还是值夜班的单亲父母，上帝总会带给我们平静、力量和安慰。我们需要继续前行，不断的努力面前

我们在华盛顿的这群人永远都不要停止寻求上帝，寻求上帝的智慧，并且按照上帝的心意来服事公众。

这就是为什么艾森豪威尔总统，和参议院 Carlson 在 64 前通过这个聚会获得智慧的方式。他们由此开启了这一伟大的传统，他们一起合作的事可不止这一件。

我要告诉你们接下来的故事，仅仅一年之后。参议员 Carlson 与其他国会议员，通过了一项决议供总统签署，这份决议加入“Under God (上帝之下)”在我们的忠诚誓言之中，这是一件伟大的事。

因为这就是我们存在的原因，我们将会成为什么样的本质，这也是我们的民众所期待的，一个在上帝之下的美丽国家，谢谢你们，上帝保佑你们！上帝祝福美国，非常感谢你们！

The Saints in Jackson County had lost household furniture, clothing, livestock, and other personal property; and many of their crops had been destroyed.
