Dear Mr. Harris,

I am Counsel of Record for the County of Maui on this case. I am responding on behalf of the County of Maui Corporation Counsel, the chief legal advisor and legal representative of the County, to Mr. Henkin's letter to you that informs of a possible settlement of this case. This case has not settled.

On October 1, 2019, Corporation Counsel responded to County Council Chair King's letter of September 25, 2019 (a copy of which was attached to Mr. Henkin's letter) in which Chair King requested that Corporation Counsel execute the settlement agreement and withdraw the County's petition to the Supreme Court. Corporation Counsel informed the Chair that the Mayor must agree to settle the case and withdraw the County's petition. At this time, the Mayor has not agreed to do so. A copy of this letter is attached.

Thank you for your letter dated September 25, 2019 regarding the abovelisted matter. As you are aware, I have been out of the office for the last two weeks, only having returned yesterday. Because this matter is of great importance, I am able to provide you with a brief response, that will be supplemented with additional case law and analysis at a later date.

 You have requested that my office execute a settlement agreement consistent with Resolution No. 19-158.

It is our position that withdrawal of the appeal before the U.S. Supreme Court must be agreed to by the Mayor. As of this date, Mayor Michael P. Victorino, has not agreed to withdraw the appeal.
