ORDER OF COURT

Entered: November 29, 2017

This is an appeal from the district court's decision to abstain under *Younger v. Harris*, 401 U.S. 37 (1971), and to dismiss without prejudice plaintiff's claims against the defendant in her official and individual capacities. Judgment entered in the district court on May 9, 2016 and plaintiff appealed. This court heard oral argument on November 3, 2016. On May 3, 2017, the Commonwealth of Puerto Rico filed a petition under Title III of PROMESA, 48 U.S.C. §§ 2161, *et seq.*, for adjustment of its debts. Under section 2161(a), the bankruptcy stay provisions of 11 U.S.C. §§ 362 and 922 are incorporated into PROMESA. In light of the Commonwealth's PROMESA filing, we direct the parties to show cause within fourteen days of the date of this order whether the automatic stay applies to this appeal.

The parties are directed to state with specificity the reasoning behind their conclusion one way or the other and in particular how the capacity in which defendant is sued might affect the section 922(a) analysis. The parties should also address the question of whether defendant's position as a member of the judicial branch of Puerto Rico affects the analysis of whether the stay should apply.
