
RULE 12.6 NOTICE TO THE CLERK OF THE COURT

Pursuant to United States Supreme Court Rule 12.6, Petitioner State of Arizona provides notice to the Clerk of the Court of its belief that the following party to the proceeding below has “no interest in the outcome of the petition”: the Honorable Kevin B. Wein, Commissioner of the Superior Court of the State of Arizona, in and for the County of Maricopa.

Commissioner Wein lacks an interest in this case. This judicial offer was only named as a nominal party to the proceeding below pursuant to Rule 2 of the Arizona Rules of Procedure for Special Actions, which requires a party seeking special action (i.e., interlocutory) review to “join as a defendant the body, officer, or person against whom relief is sought.” Petitioner State of Arizona named Commissioner Wein as a party below because he issued the order granting bail to Respondent Guy James Goodman, for which special action review was sought at the Arizona Court of Appeals. The special action proceeding is now complete. As such, Commissioner Wein does not have an interest in the outcome of the Petition. Respondent Goodman is the real party in interest.
