#### MOTION FOR APPOINTMENT OF COUNSEL

- 6. While Mr. Mongaras in in private practice, he has devoted a great deal of time within his practice to federal CJA appointed cases at both the appellate and district court level.
  - 7. Mr. Mongaras has been a member in good standing of the Texas State Bar since 2006. He

is also a member of the Bar of this Court.
