

NOTICE IS HEREBY GIVEN pursuant to Rule 12.3 that a petition for a writ of certiorari in the above-entitled case was filed in the Supreme Court of the United States on October 5, 2018, and placed on the docket October 11, 2018. Pursuant to Rule 15.3, the due date for a brief in opposition is Tuesday, November 13, 2018. If the due date is a Saturday, Sunday, or federal legal holiday, the brief is due on the next day that is not a Saturday, Sunday or federal legal holiday.
