FINAL ORDER

Upon mature consideration of the parties' pleadings and the authorities cited therein and exhibits attached thereto, and a review of the record in the criminal case, which is hereby made a part of the record in this matter, the Court finds that Wright is not entitled to the relief sought for the reasons stated by the Commonwealth in its Motion to Dismiss.

Given that Wright has failed to establish he is entitled to relief, his motion is untimely and must be dismissed. Rule 1:1; *see Rook v. Rook*, 233 Va. 92, 95, 353 S.E.2d 756, 758 (1987) (a judgment is final and conclusive after 21 days absent proof of extrinsic fraud upon the court or a lack of subject matter jurisdiction).

It is, therefore, **ADJUDGED** and **ORDERED** that Wright's Motion be, and is hereby, **DENIED** and **DISMISSED**, and that this matter is stricken from the docket of this Court. No hearing is necessary when, as here, the record demonstrates that the claim is frivolous.

It is further **ORDERED** that the petitioner's endorsement on this Order is dispensed with pursuant to Rule 1:13 of the Supreme Court of Virginia.

The Clerk is directed to forward a certified copy of this Order to the petitioner, and to Assistant Attorney General Victoria Johnson, counsel for the respondent.




