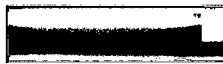

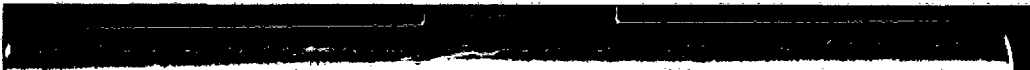

CONSTITUTIONAL AND STATUTORY PROVISIONS INVOLVED

I come before the Great Supreme Court of United States of America, with conflictual topics affecting the future of Our Government and the population at bay. As me and my family stand strong but my children as well as our rights were severely violated. Please accept my case because it is vital to the future Human Race and our Planet. So, if I may present this Constitutional Case.

As far as the Defendants go in this case, first North Dakota ruled illegally on my parental rights and sentencing. This is discussed in the Reason for Granting My Case further as well as I was extremely discriminated against.

South Carolina did nothing to protect my innocent sons Welfare as he reported sexual abuse to me and a Family Councilor on his Fraternal Grandmother. DSS unfounded his case and I left scared we both would end up dead or I would come back for him as I couldn't share him with who I suspect are pedophiles.

Morgan Lewis & Bouchius got my children GSI'd in a Lawsuit that has been going on for five years. They committed International Malpractice and Judicial Fraud, while pimping and grooming my kids and putting USA in detrimental circumstances almost waging War because of negligence.

See I believe I have spontaneous birthed kids from the hypoesthesia that energy can neither be created or destroyed only converted and most of it is lost as heat, now I am not sure as to how this happened, but I hear them and I know they are real.

I also suspect me and my families blood can cure Disease, as my late Father died from Lupus which is an Autoimmune Disorder and I have beat some incurable viruses and my sister has a mold that grows around her dirty plates which is a penicillin and possibly a bacteria cure.

I personally opened the Fifth Amendment by making a document to the Law group Morgan Lewis & Bochius and enticing The Grand Jury which is Investigating Power Rights. I put some of my Trademarks on line like WWEEI, which is World Winn Economics Economy Incorporated Enterprise Emotional Transformations, Emotional Essence, and Mother Therese's Farm and Ranch, I sue to keep these titles and surrender the proprietary of them to United States of America with me having Revenue Rights. With the Enticement done and this International Malpractice that they conducted themselves in by an infamous crime being Child Aversion as well as me losing two children in two States as in twice jeopardy of life or limb clause force open the private property for just compensation and allows this case to take the rights from our citizens which is on a capitation, as it is Constitutionally accepted from an Article that states there is no direct Tax or capitation unless

proportion of the census or enumerated be directed herein and putting the land in a Natural Federal Reserve as it is getting scarce as a Resource, so protecting it in an Federal Reserve by satellite surveys and giving the people 4 million dollars per person as well as every citizen getting an inherited Net Worth Deed and having a Socialized price of 600\$ a month per rent. They would also get a Gain Ration of 1000\$ a month.

I am asking for 30% of the capitation, the D.I.C, and request for Oil & Mineral Rights on the Land and suggest Emerson Conversion which is a copyrightable way to rig of mine I did give to Amoco and if there are other Oil and Mineral Companies that are in the USA, please make room for them., Then me and my family would get 10%, The people would have work dividends of 10%, and the Government would get 10% as a Government Dividend Monies. This leaves the US Treasury with 70% and they can use The United States Treasury Enterprise Trust & Bond. The American Judicial System will have the decision making Power and I suggest making a Branch to make Final Debate as to where US Funds go

Now I would like to address The 14<sup>th</sup> Amendment whereas I was denied equal protections of the law, there was a rebellion and crime. As I exploiting myself then there is the child aversion; and from this Lawsuit, I was denied immunities from relief. I would like to settle with consistent Government and D.I.C policy. Because this 14th Amendment is open 21 year old males could take the seat of the Government, or I could prosecute being the Government with my family, however I want consistency in USA and I believe that the rollercoaster of our Government is the biggest failure for infrastructure our Country has, so I would like to settle on keeping positional power consistent as the 14<sup>th</sup> Amendment allows a Constitutional Right to abridge the Right to Vote. This settlement will ensure the Judicial System, the President, Vice, Executive, Congress and all the Seats Government to stop this parade in power and keep our Country secure by asking for Career Term Politicians meaning they shall remain in positional power even beyond a Brain Transplants.

I have a lot of Intellectual Property, including The Helix, which catalyzes Salt into Gold and Diamonds. Congress has the ability to Tender Currency and Coin the money Constitutionally. I will give U.S.A the Proprietary over this for 1000 Tons of Gold and Diamonds as well as Revenue Rights of 30% on an 8% Exertion Tax that me and my family receive. Congress can Lease out the ability to International Power's on a Commerce Deal, however if they where to lose any of my Property Rights, I would like it Ruled and stated that my family get the Intellectual Proprietary Rights back.

With this settlement I am asking for the D.I.C Policy, the Drug Identification Card. This would open the door for a brand new America. Because I was punished so severely and sentenced to hole, lost custody of my kids, and this case had so much Malpractice I think my idea for implementing this Policy would work.

As it would make a Measure on the Bar and a new Ticketing System. This would ratify America. Because it consists of a new Law & Order. It would have Court Online, be based off of Fines that are generating through The Public every 90 days, Liberate Society, contain Drug Control, and be America's Legal System.

I propose we make a Socio Economic Bill which combines all of U.S.A's standing Bills, and forces an opening in the Constitution from my case and I ask that a reassessment be in this Ruling as it would be fruitful to be able to Veto lost causes and beneficial to our Citizens. The Socio-Economic Bill is a circumference Bill that unifies our Country and allows for Foreign Nations to Sublease out our ideas within A Peace Treaty

Capitation in a Free Enterprise System, whereas, 30% of all ascetic revenue going to United States of America I am asking for 10% of everything for me and my family; then having 10% going to the Government in personal Dividends, & 10% going to the people in a work dividend as the Court can rule on the remainder 70% of this capitation

With the Ticketing System, because Invasion was so big in my case I ask that it becomes an Invasion Law, whereas 1 person spies on 100 people in a huge office building filled with a tracking Sat alight system from there new Federal ID that will put a 100 feet surveillance around themselves as well as a circumference around their Home Domain. This will allow for Red Flag Tickets every 90 days as a Fine. The people will be able to go for Trial within the 90 days to get their Fine reduced or dismissed, also Lawsuits will need to be completed in 90 days. However, it should be easy to get an Attorney because of the Bar Bill Measure that comes out of this case as a result of this Malpractice. Their D.I.C will be shut off after 3 repeat offences in 5 years for 30 days and if they keep offending after 3 shut offs they will serve 18 months in the new prisons which will be an involuntary servitude like the Constitution says. They work for 1 dollar an hour on one of the Prisons manufacture lines, like sewing or making tires and be housed in single cells. This way we have a Prison Industry as they will also receive counseling and medication. Me and my family would like to only have to serve 90 days ever for my severe and unethical punishment. And we will be Federal Protected Species on our Federal Protected Species Reserve.

I also have an idea for the Renovation for Relocation which are applications on jobs and homes around the USA. Where we would set up a major Database that does a Character Aptitude and Personality Assessments as well as Job Location. All the citizens would need to log on here to get their Net Worth Living Deed which ever citizen is entitled to. This will be an up grade in their home and job or they can keep what they have. The citizens will get just compensation for everything they own plus 4Million Dollars and their share at the USA Steak. I am asking for 4 million Acres and to receive 30% of that, with Donald Trump getting 17% of it and 30% for himself and the rest going to his United States Officials, Congress and the Senate will get 8% a piece, the Judicial System will receive 14%, Morgan Lewis & Bochuis 2%and the rest disputed throughout the Seat of the Government Including the DEA, CIA, FBI, Military and the Executive System. I ask for the Helix to tender this project.

For taking the United States Capitation we would like to offer our citizens the Gain Ration of 1000\$ a month— including 600\$ rent 400\$ personal. This will come through the Monetary Portal Flow System which will be the new Banking Measure. The people will have to hit Access Funds at the beginning of the month to get their Gain Ration and their Work Dividend. Right next to the click will be the Red Flag of their Tickets

Emersion Conversion is a new way to mine oil as we are also asking for Oil & Mineral Rights- it uses psi on two vertical pipes at a 46 degree angle and pushes the pressure from one pipe and carbs out the pump of Oil so there is a back drafted pump of Emerged Oil

People's work money as 10% of 30% from D.I.C, Capitation, and Oil money which any working or disabled citizen can receive. Then their Salary which I also would like the Helix to tender in a list of jobs and standard allusions for certain positions. Which I would like to see me and my family be as Special Intelligent Federal Agency making 10 million \$ a month plus 30% Revenue Rights on all our Copyrightable invention, discoveries and concepts then putting our President Mr. Trump at 1000 million Dollars a month...

I would like to share Custody of the kids with the Government and allow them when their 18 years old to have joint Guardianship of themselves with the United States of America. I also will surrender joint Guardianship of myself to the United States of America. They would like an iPhone, iPad, and a Nook, just like the ones I sent to James and Jacob. I will by them all ones if you'll pay the monthly bill.

I am asking for 10 million dollars for this case and 40 million for proprietary of my intellectual property thus far with me and my family having 30% Revenue Rights but these Rights come back to my family if their sold

I also want Expungement of record as I was illegally convicted.

There were Doctors that were sued in my case and I need my Adderall, so I want to make Doctor Response which will be an online Dr. that people and the Government can get narcotics from easily

We are asking for 30% of 4 million acres plus 2 sections in every State. We will give the 70% of 4 million to the Government. I would like to settle this case on Morgan Lewis & Bochiuss with them having 2% of 70% of this land as well as offer them an Ordinance on peds. Whereas if there are pedophiles in our Country the Law group can allow them on their land.

I am certain I have Spontaneous Birth kids and want them all.

I am asking for my clones too.

I would like everyone in our Country To do a CDC/DNA Test, we would bank their blood cell for Brain transplants and see what pathogens they have as well as identify all of the population.

I also am asking for Virginia and West Virginia to be a part of DC giving more property to our Federal Government as widening the District of Columbia.

We ask for a New American Flag that has One Star and Thirteen Bar Flag

For everyone to have a National ID and it be mandatory to wear, containing the Location and Identity Chip

I would also like to sue for Rowe vs. Wade, in which I had an abortion when I was 18 because of interferon, it hurt really bad. I would like abortions to be done by caesarians and the fetuses grown in a fish tank.

This Case is a Sealed Case.

HELIX Paying for Land at 10,000\$ Acre and up to 9milliom per building plus wages and salary

We could build the Cooperation that I work for, AnswerNet, which is a Telecommunications business and we could ad remote work to get out Award Letter's & Granters Notes to our population. This would have script to let all the citizens know what's going on and help them get their ID, place their applications, including their CDC/DNA Test, as the Goal is to reach everyone.

We also would have a Surplus Inflation Rate of 30% as a Direct Tax on the enumerated goods in our Country.

Every person would receive Net Worth Living Deeds and it would be illegal to be homeless, as a homeless person would be taken into custody and location means, medication, and SSI would be available.

I am also suggesting to filling a Motion of Litigation Trust of Wills on America for the Federal Government to put into a Federal Reserve, where they take the Congress man's name and Senators name, address, and phone number of every State

We need to get a settlement on the Morgan Lewis & Bochiuss case, I am suggesting 6% above my 30% whereas, we will pay half, leaving my family and I 27% and the Government putting up 3%. I can only afford 2% of my attorney fees, and am only giving the restitution on the 1000 tons of Gold and Diamond currency exchange, however we will give 3% of 4 million acres if the Government can give 3% of their 70% as well as they can have 6% of the capitation, the D.I.C, and Oil money, leaving my family with 7%. They can have 6% of the abortions in our Country As long as the Mother is informed consented and paid, she will need to lose her rights and the child can testify at age 2 if they are hurting, they can have a Reservation for their activities, but they still need to abide by American Law, however they need a Mayor and can plausibly have an Independent Senator where they make Reservation Ordinances. They can never practice Law. If I find any of my kids on their land we will prosecute for their Reservation. If they don't quit hurting my children we will file a Restraining Order.

We will share Guardianship with the United States of America. Whereas I will have joint Guardianship of my kids with me until age 18 and then they will have joint Guardianship of themselves. I will also give up joint Guardianship of myself to the U.S.A. They can have Power of Attorney under Contract. The Contract will include Informed Consent, and the Citizens Rights and Responsibilities Agency, whereas some of my family and a Government Branch as well as me will exchange our wants and needs, and Deals on our Intellectual Property.

One of the first things I need to see done, is getting my kids out of cages and on a section of land outside of Bismarck in pole barns, where they can have a cot in a 6x6 cubical with a desk and an education. The Pole Barn can be 400x200 and made half to have cots and half to have a recreation, shower, and commissary. We can build an outside play area. The Pole Barns will need to be insulated for the cold. Our goal is to build huge Octagon Man chins on our Federally Protected Species Reservation. This will take a couple years. My children need their Freedom. It is child abuse, what has happened to them. They get Soda Pop, Candy, and Coffee everyday. I can visit them too. Maybe the Military can build for us, I will pay half.

About the Abortion's, every mother will have choices, where Morgan Lewis & Bochiuss could be an option. Cob & Light our option, we would pay 10,000 per child, the Government, or other Adoption Agency, she could just abort if she wanted to or Rowe vs. Wade can have it too.

I am not sure if I am the only Mother this has happened to but I love my kids dearly.

We can make a Socio Economic Bill

We are fighting to be an incestual and inbred Tribble Family.

I want to Marry my Sons James & Jacob and have a Clone of my Dad and nephew Payson Macrea Scott and my sister Jamie can have a James and Jacob. My sister has an Attorney because her husband and Mac's dad was shot by a cop, outside of my house.

All my kids could have a Clone of us too.

We will be Companion Clones for a Government Family as long as we go together as a JLA, James, Jacob, and 2 random children. The person that gets us outside our Family will have to inherit 200 acres because of the potential Spontaneous Birth.

Donald Trump can decide who gets our Family except Morgan Lewis & Bochiuss or any other pedophile.

I came up with the capability to Clone, by taking an egg and then putting an umbilical cord Stem Cell in a blood cell and fertilizing it with a Sperm and adding reuptake exhibitors, Normorphine Y, Achiotte choline, Adrenaline, and Growth Factor.

I came up with TSS, Trump Studio Station, which can be a new TV Station. Either my Family will remain an unanimous and our case not aired or we can go public and tell the people what I sued for.

We would need to make a Measure on the incest in our Country. Whereas a mom or dad or parents and children can decide when the child is twelve and be married at ag thirteen.

I am asking for a birth certificate and social security numbers for all the Clones that came out of the case. I believe even Honorees have Clones made. I would like them recognized as citizens not just therapeutic people. I ask for huge humanitarian precautions in The Lupus Cure Foundation and that it be Family recognized. The Clones have said they are in some sort of "coffin".

The current banking system doesn't have worth if you add 0 you get 0 if you try to take 55 \$ from 1,00,000,00,000 it is impossible in 0's and anything times 0 equals 0 mathematically so it is worthless. I could figure a whole trust worthy banking system and have the formula with a conditional expression .99\$ = 1.00\$ in a Macro. Theoretically speaking it is the closest you can get to a dollar in the currency exchange electronically, this paragraph contains two logical concepts. The new system would run off "Links," USB Person # Drives, for the capitation I have figured out 2 # systems one makes over 11 zillion evolving numbers and I can make an App Software for every Nation's Treasury given the approval. The numbers use 111111111111111111-111111111111111111ABC,211111111111111111-111111111111111111BBC, or 12345678901234567890-12345678901234567890ABC, 2123456789021234567890-21234567890BBC, whereas the number is added in it's whole value constant to its position 1<sup>st</sup> and others remain the same and 2<sup>nd</sup> project. I have an idea to make ED money in consumption of digital 9's so; many 9's equal monetary flow. A government cookie can be attached to the 9 to track it and make it valuable like an add on that can be read by computers and devices or on a chip VISA and downloadable from a personal banking system online. Possibly using the Helix Gold and Diamonds to back up the tender.

I have a major Case against North Dakota where my Sons were legally illegally kidnapped and the States really did me wrong. For Jacob they had no witness or incidences and the only reason I was in all those programs was to get my son back but I worked with them and did everything as well as be honest, with James the State recognized he wasn't in their jurisdiction but Stole him to child molesters and failed to send me the files. With my Charges they lied and it was a coheres guilty plea both times. Even so I can't serve time without being dully convicted and they can't segregate me for a disability especially to the hole a place used as punishment.
