STATEMENT OF THE CASE

When I APPLIED for SNAP Foodstamp Benefits in April 2014 There was no information about Applying for Disab.ity Financial Assistance (DFA) at The Ohio Department of Job and Family Services. I went to The office (ODJFS) a number of times over about 2 years, trying to get DFA.

I APPEALED in Common Pleas Court Franklin County and won my Court Appeal. Case # 16CVK-007427 Date 12-14-16 - Ohio Department of Job and Family Services (ODJFS) Case # 5111331522 New Case # 5111331533, At The State Hearing (ODJFS) I lied under oath and ACCUSED me of being uncooperative in the APPLICATION process for DFA and not submitting any forms to The Agency (ODJFS) at any time regarding DFA. I did have Evidence the Document Receipt Showing I did Submit DFA forms - By this time I Should have been getting DFA for over 1 1/2 years.

At this point there should have been talks with me regarding a Compensation Settlement from Ohio Department of Job and Family Services.

I then APPEALED my case to the next higher Court - the tenth District Court of Appeals to try to reach a Compensation Settlement from ODJFS. For Medical Reasons I was unable to file a brief on time and The ~~Court~~ Dismissed my case.

On June 1st 2017 I then APPEALED to the Supreme Court of Ohio Case # 17-0723, The Court declined to Accept Jurisdiction, This is where The Court made a Error.

In July 2017 I Sent ODJFS my Medical Form three times by Mail and Fax. I heard nothing back from ODJFS. I never did get DFA Benefits. Now ODJFS is say since I get Supplemental Security Income I'm not Eligible DFA Benefits, not true, I still qualify, I believe I have Experience Discrepancies. I'm Asking ODJFS for a Compensation Settlement.

REASONS FOR GRANTING THE PETITION

IAppealed to the Supreme Court of Ohio. The Court did not accept Jurisdiction Regarding my Case. I Believe This Decision by The Court to be Erroneous.

I have Evidence and Won my Court # 16CV-007427 Dated 12-14-2016 . In Franklin County Common Pleas Court. - Ohio Department of Job and Family Services Case # 5111331522 new Case # 5111331533

Ohio Department of Job and Family Services (ODJFS) Accused me of being unCooperative in the Application Process for DFA by not Submitting any forms to the Agency (ODJFS) at any time regarding DFA. I have Evidence which is The Document Receipt Showing I did Submit DFA forms, I never did receive any DFA Benefits. I believe ODJFS does not want and Still do qualify.

I really needed The funds (DFA) for transportation before getting Supplement Security Income From April 2014- to October 2014.


