
ORDER

MARVIN E. ASPEN, District Judge:

We have reviewed Defendant Mario Lloyd's motion for court action. (Case No. 89 CR 427-1, Dkt. No. 820.) Citing our October 22, 1997 Order vacating Lloyd's conspiracy conviction (Count I) and reducing the sentences imposed on ten other counts pursuant to 28 U.S.C. § 2255, Lloyd's motion seeks an amended judgment reflecting the changes detailed in our 1997 Order. *See United States v. Lloyd*, 983 F. Supp. 738, 743-45 (N.D. Ill. 1997) (Civil Case. No. 97 C 3020). The electronic docket summary in Lloyd's criminal case does not reflect an amended judgment was entered following our 1997 Order.

On or before May 7, 2018, the government shall file a response to Lloyd's motion specifically addressing the status of any amended judgment entered in this case. In addition,

Lloyd filed an identical motion in a related civil case. (Case No. 97 C 3020, Dkt. No. 33.) We hereby strike Lloyd's motion in the civil case as repetitive and moot. It is so ordered.
