3. Kwon claimed to Erie (Exhibit 3 Proof of Loss Claim # 010410337715)

REASONS FOR GRANTING THE PETITION

1. Kwon assert that Case does not apply limitation (2 years) by Code of Virginia § 8.01-249. (cited)
2. Circuit Court ordered without present Kwon because Kwon was not served/informed/notified of motion
3. Kwon contracted policy exhibit 1 that there is no contractual limitations period, so Order errored
4. Erie should compensate Kwon because Kwon contracted exhibit 1 policy that there is no contractual limitations period
5. Erie fabricated policy exhibit A because there is no page 002089~002102, there is diferent page #

6. If Erie's policy exhibit A is original policy, Erie violated Bona Fides (a person's honesty and sincerity of intention), Erie did not contract by proper policy, it is Erie's fault, so Erie should compensate Kwon
