Judgment affirmed. Barnes, P. J., and McMillian, J., concur.

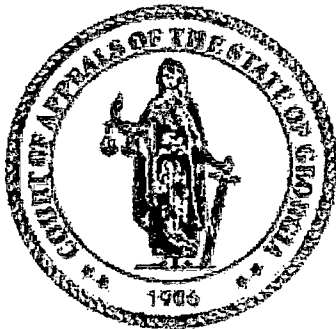

FINAL ORDER

This matter is before the Court on Southern National Assets, LLC's Motion for Summary Judgment and Motion for Default Judgment. The Court first notes that Consent Orders were previously reached with City of Roswell and Bank of America, N.A. Petitioner and United States of America have stipulated to an agreement between themselves, which is incorporated herein. Therefore, only Petitioner's Motion for Default Judgment as to so Respondents Springfield Financial Services, Inc., successor to American General Finance, Redstone Trading Co., LLC, and Roswell Station

Homeowners Association, Inc., and Motion for Summary Judgment as to James J. Bagwell and Georgia Department of Revenue remain pending before the Court. After considering the Motions, the Court finds that the Motions should be and are hereby GRANTED.

The Court hereby establishes a first priority lien in the amount of \$334,100.00, plus prejudgment interest from July 8, 2015 (the "Lien") in favor of Southern National Assets, LLC and against the property more particularly described as follows (the "Property"):

ALL THAT TRACT OR PARCEL OF LAND LYING AND BEING IN LAND LOT 409 OF DISTRICT 1, 2ND SECTION, FULTON COUNTY, GEORGIA BEING LOT 22, BLOCK A, ROSWELL STATION SUBDIVISION, AS PER PLAT RECORDED IN PLAT BOOK 122, PAGE 99, FULTON COUNTY, GEORGIA RECORDS, BEING FURTHER DESCRIBED AS FULTON COUNTY TPID: 12-1881-0409-036-8.


The Court further finds that the Lien must be satisfied prior to any other lien, claim or interest in the Property.

The Court further finds Petitioner is entitled to foreclose on the lien established herein by conducting a public sale of the Property on the Fulton County Courthouse steps during legal hours of sale, after providing notice as set forth below, and auctioning the Property to the highest bidder, with the proceeds of such sale first being applied to the cost and expenses of the sale and this action, then to the payment of the lien established herein with the balance, if any, to be repaid as provided by law. The purchaser at the foreclosure sale shall hold unencumbered fee simple title to the Property.

Prior to conducting the foreclosure sale, Petitioner must cause notice of the sale to be advertised in *The Fulton County Daily Report* once per week for four weeks preceding the foreclosure sale.

The Sheriff is hereby ordered to disburse the excess funds as follows without delay: \$12,083.34 to Petitioner in satisfaction of its 2011, 2012, 2013, and 2014 tax liens; \$36,141.44 to United States of America. The balance of such funds shall be paid to Petitioner, which shall operate to reduce the Lien established herein by the amount received.
