MOTION FOR LEAVE TO PROCEED *IN FORMA PAUPERIS*

Pursuant to Rule 39 of the Rules of the Supreme Court, Petitioner Mike Peter Gallardo hereby moves for leave to proceed *in forma pauperis* in the above-captioned case on the ground that he lacks sufficient funds to pay for fees and expenses. Mr. Gallardo is a death row prisoner who is incarcerated at the Arizona State Prison Complex in Florence, Arizona.

On December 17, 2014 the Superior Court of Maricopa County, Arizona appointed counsel undersigned as private counsel for Mr. Gallardo upon counsel's retirement from the Officer of the Maricopa County Public Defender, where he had represented Mr. Gallardo since 2011 in Post-Conviction Relief proceedings as a Deputy Public Defender. That Order is attached as Appendix A. Mr. Gallardo's

declaration of in support hereof is attached as Appendix B. Accordingly, Mr. Gallardo respectfully requests that he be permitted to proceed *in forma pauperis* in this Court.
