STATEMENT OF THE CASE

Petitioner was provided an incorrect Social Security number. The number used belonged also to a Cuban Nationalist who resided in Miami-Dade County, Florida. Earnings belonging to Petitioner were given to the other party. Petitioner provided deeds, work history, court cases to establish wages earned in Boston, Mass., New York, New York, Las Vegas, Nevada and Atlanta, Georgia does belong to Petitioner to ensure he received proper credit for disability payment. Administrative Judge for Social Security declined to review and Petitioner asked the federal Courts to review all documents which they failed to do so.

REASONS FOR GRANTING THE PETITION

To allow Petitione to obtain proper credits for disability. Petitioner earned the income presently being collected by Cuban Nationalist in house arrest for distribution of drugs.

Petitioner did challenge the Administrative Judge decision not to include and/or review exhibits to prove earnings earned in which Petitioner is entitled to.

CONCLUSION

The petition for a writ of certiorari should be granted.
