## STATEMENT OF THE CASE

1. I Ram Saxena knew Nabilsy yunus Abud (Now called ABUD) That he is interested in face Coding machine after face cosmetic surgery This machine is useful People use frozen faces, but not so effective.
2. I started helping Abud to make the machine. He has lots of money, many new Mercedes car He needs money so he got from me \$7500<sup>00</sup> Machine was ready & marketed, I was the person who helped him in marketing. He still asking more money from me & giving cheque in advance. I did for 3 cheques, but they all bounced.
3. Superior Court of Los Angeles (central) I filed the complaint for \$150,000. By 2 yrs nothing has happened in lady judge court. Interest was rising.
4. So I went to ~~the~~ Bankruptcy Court. Nothing happened there. BAP NO. 14-1444
5. Then I went to Ninth Circuit Appeal Court Court No. 15-60064. There was my success Abud was made bankrupt. Before bankruptcy he sold the machine patent to a Syrian guy. So house, and 4-5 Mercedes car which he is exporting to Syria, was left.
6. I tried to sell the house, but no body want to give more than \$400,000<sup>00</sup>.

7. I want to take money & give it to my wife from whence I borrowed & given to ABUD, the defendant.

8. Judge Debra J. Saltzman has made a story on the instruction of somebody called Fannie Mae. Neither I asked to dismiss bankruptcy. I failed to make the lease deed of the house

9. I asked recording, First American title insurance Company, 3 American Way, Santa Ana, Ca 92707, but I failed. Norwalk (County office) did not help me. I asked police, Benn, 18135 Bloomfield Ave, Cerritos, Ca Tel. 562 860-0044.

10. Say California is a County (Although it is a state). Every year Reader digest publishes one County in 278 Counties who is most corrupt County, I think California. So I am writing a book and compare California as a County, or Puerto Rico etc etc. President Trump think by show off by making a China wall, illegal immigration will be, less. Fannie Mae says it will increase 10 times. He want to bring white from South America.

## REASONS FOR GRANTING THE PETITION

1. This is a fraud case in appeal court. First judge gives order to make him bankrupt. As bankruptcy court has said that \$75,000<sup>00</sup> was given loan for few days but he refuses to pay loan. He asked more loan to complete the machine. He gave 3 predated/post dated cheques, that they will be honoured. But they were not honoured. They were bounced. The appeal court judge said that 3 cheques are enough. No more cheques are needed to make him bankrupt. So he was made bankrupt.

2. This is a mistake judge Saltman did. As President Obama left The white house and President Trump came. He wanted only white to enter America, to make America great. But Gov. Brown is white & Fannie Mae (in California) There is height of corruption. Judge Saltman saw ABUD white, because he is from Syria. So she cancelled his bankruptcy. Now he has not to pay bank \$800,000<sup>00</sup> (Mortgage) He has not to pay Saxena as bankruptcy of Abud is called off as house is not registered in his name. (18)

4. As every body knows Court & County has good relationship. I tried to <sup>change</sup> ownership of the house, but I could not do so. I had a letter from my attorney, which is enclosed in Appendix. I went several times with my Senator Kamala Devi Harris to accept this letter & take \$140<sup>00</sup> but both clerks refused each time as he is no more War Council, he was disbarred. In 2010 he was not disbarred


