ORDER

Plaintiff, a Georgia prisoner, has filed a complaint, which the Clerk has docketed as a civil rights action. (Doc. 1). It appears, however, that Plaintiff seeks to raise a habeas corpus challenge to his rape conviction in Camden County, Georgia, which is located within the jurisdiction of the United States District Court for the Southern District of Georgia, Brunswick Division.

It is the long-standing practice of the United States District Courts for the Northern, Middle, and Southern Districts of Georgia to transfer all 28 U.S.C. § 2254 petitions to the district within which the state prisoner was convicted. *See* 28 U.S.C. § 2241(d); *Eagle v. Linahan*, 279 F.3d 926, 933 n.9 (11th Cir. 2001) (recognizing practice). This practice allows each district court to consider habeas matters coming

only from state courts within its jurisdiction and ensures an equitable distribution of habeas cases between the districts of this State.

Accordingly, this action is **TRANSFERRED** to the United States District Court for the Southern District of Georgia, Brunswick Division, for further proceedings.¹

¹The same outcome is dictated by the venue rules that apply to 42 U.S.C. § 1983 actions in federal court because the events about which Plaintiff complains took place within the territory of the United States District Court for the Southern District of Georgia, where the named Defendant and other potential defendants are located.
