

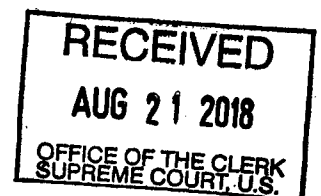

- d) (1) Copy, as you have now requested, of the (Aug. 11, 2018) corrected Writ of Certiorari / Appendix and detached Certificate of Service.




e) And (1) Copy of Petitioner's **(Aug. 13, 2018)**
