My Name is Deandre' Russell. I am a Christian, Black American and a natural born citizen of this country and a resident of Huntsville, Alabama. I am also a current pro se' litigant in the U.S. Supreme Court. I am writing to you today, your Hon. Chairman, for several important reasons. First, and foremost, because it is my understanding that I am currently and have been deprived of my rights, (by the Federal Courts) of the Federal Laws and Constitution, that were put in place by our Founding Fathers and that these denial of rights has been caused by those who have been ratified as federal judges, to uphold these Laws and the Constitution, and who are approved through this U.S. Senate and this Honorable Senate Judiciary Committee.

As proof that I offer, as to my being deprived of these rights, I am presenting to you, a copy of the (August 14, 2018) Writ of Certiorari, to the U.S. Supreme Court, that was denied without an opinion, along with a copy of my recently filed Petition for Rehearing. It is further my understanding that Congress, through this Senate Judiciary, are the body and branch of government that makes the appropriate and equitable laws, and amendments to those laws, that the courts are to follow. The Writ of Certiorari along with my Petition for Rehearing that I am now presenting should display that these laws are not being carried out by the courts, involved in these matters.

This now leads to my second reason for writing to you. Let me first say that I am aware that this Senate body does not have the authority nor the jurisdiction to change any decision that the high court or any court's decision, involving my case or any other. But it is now my intention to not only bring these matters to your attention, but to also make known that Congress, through the House and Senate Judiciary Committees should and must do a better job in protecting citizens of this nation's rights from those court(s) and judges, that are not following the laws that this Congressional body and others have established. In other words, I agree with our current president that Congress must reign in courts and judges that are not only failing to carry out the laws, established by Congress, to many citizens of this nation, but who are also failing, in this case, to present equity and justice, in the realm of consumer

debt, especially to those who may be poor, sick, uneducated or simple an average working class citizen, who is not an attorney.





Dear Sir or Madam,

My Name is Deandre' Russell. I am a Christian, Black American and a natural born citizen of this country and a resident of Huntsville, Alabama. I am also a current pro se' litigant in the U.S. Supreme Court. I am writing to you today, to present a Complaint that I now have. I have now been a pro se' litigant for nearly (7) years, in a case involving alleged fraud and gross negligence, by opposing parties of my (Dec. 31, 2013) filed lawsuit. It is to my understanding that my ***Civil and Constitutional Rights*** have been possibly violated, by ***Judicial Officials***, of the courts in these matters. The Record will show that I am not only being denied equitable relief, in these matters, but moreso, it appears that I am being denied my right to the Federal Laws and our Constitution, mainly ***my due process rights***. I do not know if these alleged violations classify as an ***Obstruction of Justice***, for which is why I am now relying on this Civil Rights Division to instruct and protect me of my rights.

As my proof of this alleged denial of my rights, I am presenting to you a copy of my (Aug. 14, 2018) Writ of Certiorari to the U.S. Supreme Court, that was denied without an opinion, along with a copy of my recently filed Petition for Rehearing. As noted to the Justices of the Supreme Court, in my Petition for Rehearing, I cannot see how anyone could read the Aug of 2018 Writ to this Court and its contents, and if found to be true, can say that I was treated with equity and justice, as well as my Civil and Constitutional Rights were not denied. I further cannot see how the allegation presented does not demand an answer of true, false or frivolous.

Because these alleged violations involve judicial officials, of the Federal Courts, along with the fact that the Hon. Justices of the U.S. Supreme Court has shown the unwillingness to comment on these matters, which has now been displayed by a denial of the Writ, with a "no opinion" I am asking that an outside entity, such as this Civil Rights Division, would examine the Writ and all of its contents, along

with the Petition for Rehearing Brief, to determine and present to the U.S. Supreme Court, its findings as to whether these actions by judicial officials classify as a violation of my Civil and Constitutional Rights.


It should also be noted, to this Civil Rights Division that a personal letter along with an exact copy of the Aug. 2018 Writ of Certiorari and the recently filed Petition for Rehearing has been sent to the Honorable Charles Grassley and Dianne Feinstein, who are the Chair and Co-chair of the Senate Judiciary Committee, concerning the request for hearings on the need for Congress to better protect the citizens of this nation, by a judicial System that would allow a families life to be ruined by an, "*Opinion or Lack Thereof.*"

For the above reasons, I am once again asking that this division would process this Complain to the appropriate personnel, who would investigate and present its findings as to whether the facts and evidence, of these matters present violations of petitioner's Civil and Constitutional Rights, by judicial officials, and to present these findings to this U.S. Supreme Court and the Senate Judiciary Committee.

As this letter and its contents reaches this department, it is my intention to make known that I will also be presenting an application to request to the Honorable Justices of the U.S. Supreme Court to set-aside the denial of the Writ, and Grant the Rehearing, along with a request that the rehearing would be held in abeyance, until this department presents its findings to this court and the Senate Committee.

Finally, I end this letter by making known that it was never my intention to bring this much attention to these matters. Rather, I am simply a Christian, American Citizen, who is a Black Man in this country, who was and still is, seeking relief from those who have caused irreparable harm against me and my family by denying me the Rights entitled to me, by the Equitable Federal Laws created by our Congress, in regards to Bankruptcy Law and Consumer Debt and our Federal Constitution, as it pertains to the Due Process Clause, for which it is my contention that I have been denied both of these rights.


