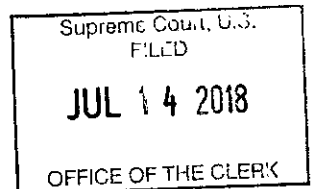

STATEMENT OF THE CASE

As outlined in the brief, double jeopardy implications affected this case when State and Federal authorities went beyond mere cooperation. In fact, the Federal government directed the disposition of State charges with the intent to effect a dual prosecution for the same conduct. Further, a current Supreme Court case is currently reviewing the double jeopardy implications of dual sovereignty prosecutions.

REASONS FOR GRANTING THE PETITION


