MOTION FOR EXTENSION OF TIME

IN ACCORDANCE WITH RULE 30.2, COMPUTATION AND EXTENSION OF TIME. RULES OF THE SUPREME COURT OF THE UNITED STATES. I MOTION THIS COURT TO EXTEND THE TIME TO FILE A PETITION FOR A WRIT OF CERTIORARI. REASON GIVEN:

I WAS TRANSFERRED FROM SUSSEX II STATE PRISON TO RED OXION STATE PRISON ON APRIL 3, 2018.

AT THE DATE OF THIS WRITING, JUNE 9, 2018, I HAVE NOT RECEIVED MY SECOND BOX OF PROPERTY CONTAINING ALL LEGAL MATERIAL.

WHEN BEING TRANSFERRED FROM ONE DEPT. OF CORRECTION FACILITY IN VIRGINIA TO ANOTHER, ONE BOX OF A PRISONERS PROPERTY IS SHIPPED WITH THE OFFENDER. THE OTHER BOX ARRIVES AT A LATER DATE.

I WAS NEVER GIVEN THE FORMS UPON BEING TRANSFERRED TO PAY SHIPPING AND HANDLING. WHICH FOR SOME REASON OR ANOTHER IS CUSTOMARY AMONGST PRISON OFFICIALS.

MY MOTHER HAS TRACKED DOWN MY PROPERTY AND PAID SHIPPING AND HANDLING. AN INFORMAL COMPLAINT SETTING OUT, "I HAVE NOT RECEIVED MY PROPERTY," "NOR INFORMED OR GIVEN PROPER FORMS TO PAY COST", HAS BEEN FILED. THE RESPONSE STATES "WILL ISSUE YOUR PROPERTY ONCE IT ARRIVES." IF NECESSARY I CAN PROVIDE THE TRACKING NUMBER TO THE COMPLAINT.

FINALLY, ON JUNE 4, 2018, LISA NESBITT SENT THE ENCLOSED DIRECTIVE, "THE ORDER DENYING REHEARING MUST BE APPENDED..."
