RULE 44. REHEARING

THIS SUPREME COURT OF THE UNITED STATES IS THE ONLY COURT SPECIFICALLY ESTABLISHED BY THE CONSTITUTION OF THE UNITED STATES.

THE COURTS USUAL "THE PETITION FOR A WRIT OF CERTIORARI IS DISMISSED" WOULD HAVE BEEN SUFFICIENT TO CONCLUDE THE MATTER, HOWEVER;

THE COURT OPINES: "AS THE PETITIONER HAS REPEATEDLY ABUSED THIS COURTS PROCESS, THE CLERK IS DIRECTED NOT TO ACCEPT ANY FURTHER PETITIONS IN NONCRIMINAL MATTERS FROM PETITIONER . . ."

FOR THE RECORD, I PETITIONER JOHNSON HAVE NEVER MADE A NONCRIMINAL FILING.

IF THIS SUPREME COURT WOULD HAVE PAID ANY ATTENTION TO THE CERTIORARI PRESENTED BY PETITIONER, IT IS CLEAR HE MAKES THE SAME ARGUMENTS PRESENTED PRIOR TO AND HELD BY THIS COURT IN MAPLES V. THOMAS AND MARTINEZ V. RYAN.

NOT ONLY WAS PETITIONER ABANDONED BY A HABEAS ATTORNEY, HIS HABEAS PETITION (THE ONLY WRIT EXPLICITLY PROTECTED BY THE U.S. CONSTITUTION) WAS DENIED AND DISMISSED DUE TO NO FAULT OF HIS OWN.
