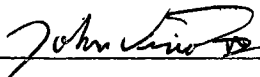

: MOTION FOR LEAVE TO PROCEED IN FORMA PAUPERIS

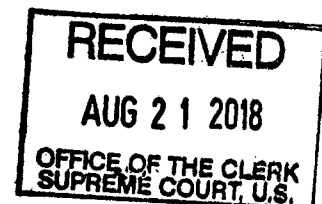
The petitioner ask leave to file the attached petition for writ of certiorari without prepayment of costs and to proceed in forma pauperis.

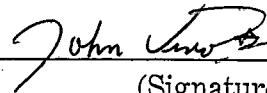
