THE COURT:

The petition for writ of mandate, transferred to this court by the Supreme Court of California with directions to deny the petition if it is substantially identical to a prior petition, has been read and considered by Justices Benke, Huffman, and Nares. Judicial notice is taken of the petition for writ of mandate and order filed in case No. D072744. The present petition is substantially identical to the prior petition and, in accordance with the Supreme Court's directions, is denied as repetitious. (*Hagan v. Superior Court* (1962) 57 Cal.2d 767, 770-771.)

The court advises petitioner the proper procedure to obtain review by the Supreme Court of California after this court summarily denies a petition for writ of mandate is *not* to file a new petition for writ of mandate in the Supreme Court, but to file a petition for review in that court within 10 days of the summary denial by this court. (*Hagan v. Superior Court, supra*, 57 Cal.2d at pp. 769-770; Cal. Rules of Court, rule 8.500(e)(1).)
