MEMORANDUM FOR THE UNITED STATES

Petitioner contends that his prior conviction for attempted armed robbery, in violation of Fla. Stat. §§ 812.13 and 777.04 (1997), was not a conviction for a "violent felony" under the elements clause of the Armed Career Criminal Act of 1984, 18 U.S.C. 924(e)(2)(B)(i). The Court is currently considering a related question in <u>Stokeling</u> v. <u>United States</u>, No. 17-5554 (argued Oct. 9, 2018). The petition for a writ of certiorari should therefore be held pending the Court's decision in <u>Stokeling</u> and then disposed of as appropriate in light of that decision.\*
