

AFFIDAVIT IN SUPPORT OF MOTION
FOR LEAVE TO PROCEED IN FORMA PAUPERIS

Rodriguez, being first duly sworn, depose and say that I am the petitioner in the above-entitled case, In support of my motion to proceed in Pro Se, I state that because of my poverty I am unable to pay the costs of this case or to give security therefor; and I believe I am entitled to redress.
