AFFIDAVIT OR DECLARATION IN SUPPORT OF MOTION FOR LEAVE TO PROCEED *IN FORMA PAUPERIS*

I, Marie Assa'ad-Faltas, MD, MPH, am the petitioner in the above-entitled case. In support of my motion to proceed *in forma pauperis*, I state that because of my poverty I am unable to pay the costs of this case or to give security therefor; and I believe I am entitled to redress.

I certainly hope the remaining false convictions against me would be reversed as soon as possible so I can build the house I invented for my mother and me.

If, “this case” means this *petition for a writ of certiorari*, the answer is NO. If “this case” means the underlying criminal charge, my family has paid fines and appeal bonds for me.

Yes, some of the transcripts were paid by South Carolina’s Office of Indigent Defense, but some of them have been paid by me and I am seeking reimbursement. I have also paid to copy cases and statutes and to print and mail the application for extension and this petition and form,

12. Provide any other information that will help explain why you cannot pay the costs of this case.

Since my false arrest on 2 December 2009, I have had to spend every waking hour in my defense against the false charges. I do not have any time to work, generate income, or even get urgently-needed health care. Although I am very highly educated and diligent, this fate that has befallen me renders me destitute. My family has so far spent about two-hundred thousand dollars to keep me alive and sheltered during this ordeal. I owe them that amount and they cannot keep spending on me.

I declare under penalty of perjury that the foregoing is true and correct.
