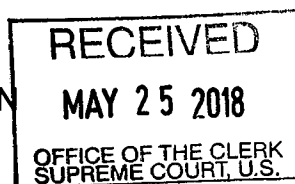

Timothy Warren Vallier, on behalf of himself, requests that Justice Elena Kagan, Justice for the 6th Circuit, extend the time for filing a petition for writ of certiorari to the United States Court of Appeals for the 6th Circuit, in the matter of Vallier v. United States of America, No. 17-1642, for a period of 60 days, or from May 21, 2018 up to and including July 20, 2018.

JUDGMENTS BELOW

1. On May 17, 2017 petitioner was convicted of 1 count of attempted sexual exploitation of children in violation of 18 U.S.C. § 2251(a) and (e) and possession of child pornography in violation of 18 U.S.C. § 2252(a)(5)(B) and (b)(2) in the United States District Court for the Western District of Michigan.

2. Petitioner timely appealed this conviction to the United States Court of Appeals for the 6th Circuit. This court affirmed the conviction by its order entered on February 20, 2018. A true and correct copy of the opinion and order of the court is reported at 2018 U.S. APP. LEXIS 3919.

JURISDICTION

3. The Supreme Court will have jurisdiction over this matter because 28 U.S.C. § 1254(1) gives the Court jurisdiction over an appeal of a final judgment of a United States Court of Appeals.

REASONS WHY RELIEF FROM TIME LIMIT NEEDED

4. Under Supreme court Rule 13.1, time for filing of a petition for writ of certiorari in this matter expires on May 21, 2018.

5. Petitioner, now proceeding on behalf of himself, lacks the financial ability to fully retain an attorney for aid in this matter and has been ignorant of many rules and procedures due to the complexity of federal law and practice.

6. To ensure petitioner correctly constructs arguments of importance and includes all required materials necessary for a petition submission to the United States Court of Appeals.

7. Petitioner also requests materials and documents that would be beneficial to a properly submitted petition, be sent to him help ensure he is able to proceed correctly and efficiently.

8. Petitioner is presently serving a 264 month sentence.
