### MOTION FOR LEAVE TO PROCEED IN FORMA PAUPERIS

Petitioner, Gerald P. Mitchell, by attorneys Andrew R. Hinkel and Thomas B. Aquino, respectfully moves the court to enter an order permitting him to proceed *in forma pauperis*. As grounds for, and in support of his motion, petitioner states as follows:

1. Mr. Mitchell is without funds to prosecute this action, and has been found by the State of Wisconsin to be indigent for the purposes of all trial and appellate proceedings in this matter.

2. Pursuant to Chapter 977 of the Wisconsin Statutes, Mr. Mitchell has been represented and continues to be represented in this matter by counsel provided by the Office of the Wisconsin State Public Defender. The Office of the Wisconsin State Public Defender is responsible for determining which criminal defendants are indigent and thus entitled to appointed counsel for representation of criminal defendants in the Wisconsin state courts. Wis. Stat. §§ 977.06, 977.07.

3. Mr. Mitchell was appointed counsel through the Office of the Wisconsin State Public Defender for representation in the Wisconsin state courts. He has also been appointed counsel through the Office of the Wisconsin State Public Defender for representation in this petition for certiorari.

4. Undersigned counsel are full-time employees of the Office of the Wisconsin State Public Defender.

5. Pursuant to United States Supreme Court Rule 39.1, Mr. Mitchell has not attached a declaration or affidavit in support of this motion. Instead, he has attached the Orders Appointing Counsel reflecting that he was appointed counsel in the state court below. Specifically, Mr. Mitchell has attached the order appointing Attorney Hinkel to represent him in this petition for certiorari, as well as the order appointing Linda Schaefer to represent him in the Supreme Court of Wisconsin. WHEREFORE, for all the reasons herein, petitioner respectfully requests that he be permitted to proceed *in forma pauperis* in this action.
