

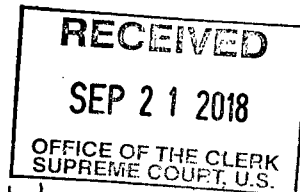
Petitioners Declaration of Filing


