**WRIT DENIED.** If the district court determines that relator is competent to proceed to trial, the court should revisit its January 18, 2017 ruling denying relator's *pro se* motion to represent himself. See *Faretta v. California*, 422 U.S. 806, 95 S.Ct. 2525, 45 L.Ed.2d 562 (1975); *State v. Santos*, 99-1897 (La. 9/15/00), 770 So.2d 319, 321. See also *State v. Thibodaux*, 2017-0705 (La. 12/6/17), \_\_\_ So.3d \_\_\_, 2017 WL 6043997. Based on the colloquy at the *Faretta* hearing, relator appears to have waived or declined to pursue his motion for a preliminary examination. Thus, we reject as meritless relator's instant claim that the court denied him his right to a preliminary examination. However, as to whether relator's waiver was proper, the transcript reflects that at the *Faretta* hearing, relator was not represented by counsel; the court denied his request to represent himself; and the court questioned whether he understood the proceedings or comprehended the seriousness of the offenses. Moreover, now that relator is represented by counsel, his competency is being questioned. Accordingly, this court's ruling does not bar relator's attorney from seeking a preliminary examination if he elects to do so.


