MOTION FOR LEAVE TO PROCEED *IN FORMA PAUPERIS*

The petitioner, Amy Hebert, asks leave to file the attached petition for a writ of certiorari without prepayment of costs and to proceed *in forma pauperis*.

Ms. Hebert has previously been found indigent and was provided appointed counsel throughout all trial and appellate proceedings in the Louisiana District Court for the Seventeenth Judicial District, the First Circuit Court of Appeal, and again in the Louisiana Supreme Court pursuant to La. Sup. Ct. R. 31(A)(1) (“In any capital case in which a defendant is found to be indigent, the court shall appoint no less than two attorneys to represent the defendant.”). *See* U.S. Sup. Ct. R. 39.1. Ms. Hebert’s financial situation has remained the same since her trial. At the time that she was declared indigent, Ms. Hebert owned a home, which she subsequently sold.

Ms. Hebert is serving a life sentence and has been incarcerated continuously since her arrest. Ms. Hebert's affidavit attesting to her meager income is attached to this motion.
