1. IS it Wrongful or illegal to use weapons of mass destruction to radiate and torture Angel Bartlett in her home or her mother's home? Michigan is a non-death penalty state. 

### Statement and Arguments

Allegan County Department of Human Services and the Courts did Peonage, Human trafficking slavery in 2001-2009. Angel was forced to leave her home and her husband. They ruined her credit they put Cheryl's Fosters electric in Angels name as soon as she moved in as if it was her bill and the bill was \$800-\$1100. DHHS uses the electric company and utilities to control. Amy Wilson DHS in Allegan County also had Angel sign a form if she was going to stay at Shirley Fosters house and this bound her to the home. This cause them to be able to take jurisdiction and ruin Angels life. They held Angel there with no compensation and without the option to leave with without her grandmother getting executed or killed by medical orders.

KVET and the DEA for framing Angel for drug trafficking for peonage for the State of MI. They did this in 2005, 2006, 2008 and 2011 which damaged her entire family not just Angel. This then put the family down and eventually put her grandmother on her death bed, so she was tortured and then prosecuted in 2011 while dying.

The argument from Allegan County and the State of Michigan DHHS Angel Hopkins, Shannon Fuller and Shannon Wagoner is that Arthur Payne and his mom defense attorney/prosecutor for Kalamazoo courts did all this for a hate crime and vengeance. Arthur Payne left a message on her voicemail on accident and it said, "move her hand its in front of the camera." Angel instantly thought that this was possible child pornography, so she told her friends but then got intimidated and then her mental state got amended to not think that it was child pornography and it was only pornography. Arthur Payne was friends with the person who was setting up Angel with the police and the mob. The police and government went along with it.

**MOTIVE:** Angel was in college for criminal justice and got a 4.0 in police supervision and management and was then picked up for internal affairs. When Angel said she wanted to be internal affairs that is when a lot of this started. The other argument was Angel Hopkins used her government power against Angel with Sarah Clausen and held Angel for peonage for the courts. Angel Hopkins use to work for friend of the Court in ALLEGAN and Sara was also a part of Allegan Courts. Arthur knew Angel was held for peonage or slavery.

They claim Arthur Payne and Dorphine Payne in 2007 had the 8<sup>th</sup> District Court prosecutors Scott Brower, Jeff Fink and Getting's, probation department and judges along with Portage Police all take down Angel for a bogus claim that Angel was NOT even apart of or even at the Scene. Stefanie Bennett a 19 yr 20 Months old female told the police Angel may have been apart of a larceny, auto theft and a CSC which Angel had no part in. This lead up to years of wrongful mental illness prosecution. Their defense is Angel may have been a part of Drug Trafficking, so they held her on the framing that KVET did. Which goes back again to the State of MI DHHS and Allegan County courts for peonage and hate crime.

Angel had been framed really bad in 2008 and the city police and Kalamazoo Valley Enforcement Team were involved. They put this on the State of Michigan

DHHS because one of the children were almost 18 and they don't like to pay for the child after they are 18 so they set up our entire family to suspicions of having illegal money \$10,000. From a car that was put in Angels name and she never drove it. This got William Foster cancelled so he didn't get money after he was 18. The family did not have any money and that put everyone down. Right before the car they framed Angel for drug trafficking just to make it look as if this is why she had the money. The argument is Lorrain Pope again did a false report on the house hold. Then they also tried to say it was Alan Farnquist and Jessica Farnquist who was Angels best friend growing up until Alan came around. Alan joined the Marine Corp, so they put a lot of this on him and he supposedly got out.

Then 2009 FBI started doing actions including framing Angel for being a terrorist after Angel dated Timothy Robertson US Parole Agent. Angel told Timothy about some of the events as they wanted her to. Angel had to report her uncle who was a molester after he kept sneaking in grandmothers' home and he gets radiated and medically executed to remove him. They stroke out her grandmother and put her in the nursing home separating the family. Then they get Angel pregnant only to have her life destroyed and her be killed. Angel was told her entire life by Western Michigan University doctors that she would die if she had children and she would die by the time she was 40 from a horrible disease that she was misdiagnosed as a child. They did this disorder program from Allegan county because she was molested when she was 3yrs old to 5. In 2009 for pregnancy Bronson and Borgess hospital put Angel in mental illness and so did the State of Michigan DHHS and FBI. A computer of her uncle who died was swapped with a neighbor and they set him up to get the computer, so no one would be detected coming in to Angels life, but she was still arrested with the FBI for no reason. Lorrain Pope was also insane and reported everyone wrongfully as she always has.

In 2010 Angel B offered Angel H a place to stay and then she got tried and set up and went mental. Angel Hopkins put Angel Bartlett in Community Mental Health for her past actions and what all had happened. Angel told Cassie Huddle another friend about depression so she too joined in. Then Angel Hopkins worked with Shannon Fuller, Cassie Huddle and other friends who were Angel Bartlett's friends since junior high. Angel believes they were prude, extreme racist, hypocritical, and self-righteous and didn't care about the results of what would happen to Angel or her family. They just wanted to take everyone down. The only one that has went down is Angel B and she is being killed. Angel has no friends or family now. Allegan Police Rick Hoyer and Jay Gibson and Allegan Sheriff Department are also to blame for their homicidal games and cover ups.

2011 Shannon Wagoner State of MI Foster care joined in on the actions for jealousy personal hate crime reasons. The US District Court Ellen Carmody, Janet Neff and Paul Maloney were also joined in January 2011 maybe before. Also, DEA KVET Ted Westra and Mike Ferguson are to blame for putting Angel and her kids in the line of fire during the 2011 Gunn Trafficking case they set up just to get Angel involved. Angel and her children could have been killed.

The Kalamazoo County Court house DHHS Child Protective Services illegally prosecuted Angel in Summer 2011. They Never gave Angel Petition A "no Due Process CFR 602.25" which was prosecution of Angel Bartlett. Angel could NOT able to get a job or get a baby sitter she was blacklisted on the central registry and never got any notice CFR 602.25 – No Due process of the Central Registry in 2011. Borgess Hospital who was at fault making her mentally ill and assisted in the prosecution with employees Tony Barker and Heather White all for the hate crime. Also Judge Michael Buck Allegan County was apart of the case.

Then the State of Michigan DHHS did a number of horrible actions Heather Giles came with Child Protective Services twice without telling Angel it was ever CPS she lied and said it was Jet Job training. Angel did nothing wrong. Everyone false reported Angel including Phillip Strickland and his family in Detroit. Lorrain Pope had issues with anyone Angel has been around. Pope use to not let Angel be around people unless they were pretty. Angel, Cassie were Lorrain's favorite no matter what they did. Angel had Lorrain Pope brainwashed and under her control. They also then put child abuse on Angel saying she was mentally ill.

Then Ted Westra working for ATF they set up an event to get Angel hit by a force, so she thought her house was going to blow up it was frieghtening. Angel was not making up a false bomb complaint but that is what they put on her 750.543m the Sheriff Department they need this charge in return. Angel believes this allowed Ted Westra to have jurisdiction. Ted Westra was in the 2011 Gunn case in KVET. Then they moved Angel to her mom's Lorrain Pope and began attacking her house with lethal radiation with her 3 year old twins inside while framing her for child abuse/molestation, Drug offenses and sex offenses. Angel has photos of the attack. Allegan County Child Protective Service Shannon Fuller and many others took Angel kids away after putting Angel in the mental hospital. Then they put the children right back at the same house that was attacked. They had to know who it was or they ordered it themselves or they must be held liable for this neglectful act.

Then they kept the kids by making her homeless by court order for several years putting wrongful neglect on Angel. They framed her with framing transmissions which were harmful. They ruined every relationship she has with anyone by separation orders. They put Community Mental Health programs on Angel to keep her away from kids that were severely damaging that raped her and caused harm to her psyche. Angel was also tortured the entire pregnancy of her son up until the day she delivered. Angel had her son they put false claims of drugs when she delivered she has proof of no drugs were in her system. Borgess hospital will still not correct this. Angel did everything she could do to try to get Stable and get her kids back and they terminated her rights and terminated her visitation. Then they put abandonment on her because Angels mom Lorrain Pope called the police on her for a false claim to get the kids for good. Angel did NOT abandon her kids they forced her to be away from them. They have MCL 722.638 civil charges and committed orders on Angel and all three kids and Angel are wards or the State. Angel wants all of the children and herself out of the DHHS ward and committed orders to be removed. Angel has no criminal charges.

For four years 2013-2018 Angel is/was constantly tortured, charged, hit with warfare and radiated by the military. Why? All because Kalamazoo psychiatric hospital torture MCL 750.85 and sexual torture MCL 750.90 programs. Melissa Blair and DHS workers have people from all over the United States doing the actions for the workers. Angel has proof and photos of license plates of who and also proof that they admit that they do torture to Angel. They also had Borgess hospital, Bronson Hospital, WEMED, Family Health Center, Community Mental Health, Counselors, all get involved to do torture and destroy Angels word to make sure they would NOT be prosecuted for their illegal crimes 18 US Code 241, 1117, 1113. The State DHHS workers claim they have immunity and can do whatever they want. They claim the adoptive parents to Angels kids also have immunity they too can try to kill Angel and get away with it.

Angel has had no real legal representation the Governor Rick Snyder and the Kalamazoo Gospel Mission Michael Brown put an executive order to SUPPOSEDLY get help for poor people to get attorneys. In fact, it was the opposite to enforce no attorneys unless you have money. Every attorney Angel tried to get involved they want no part of it. They radiated her kids in the home they could get the death penalty or have to pay \$2,000,000. if they are prosecuted 18 US Code 2332a, 2332h, 2332i. The house and Senate also changed the MCL 722.622 f to g after Angel contacted them. They claim it was to help Angel, but others said it was to divert blame against DHHS State for trying to kill Angel illegally.

The State of Michigan, Allegan and Kalamazoo Courts have a serious problem in this area with false reports and bogus claims that are prosecuted. They have prosecuted me in all of these events in the past all for hearsay Craig J. Sewell even noted this in the court hearing. All bogus claims and reports Angels life has been destroyed and her life shortened by radiation from this. Michigan is Not a death penalty state. In 2014 Borgess hospital at her son's delivery the social worker Cynthia Jubenville wrote down wrongfully Angel was on drugs and did sexual exploitation which was never true.

Angel was then put down on the Child abuse Central Registry again for losing her son. This was by the State of Michigan DHS Michigan Administrative Hearing system put Angel in the same category as a sexual exploiter and Angel did not know this or why she started getting radiated and attacked. ANGEL NEVER DID ANY SEXUAL CRIME EVER. They never arrested Angel, nor did they ever put her on a SEX OFFENDER REGISTRY. Angel pulled her criminal record there was nothing on it. Only one time after the US Supreme Court in 2017 Angel wrongfully had neglect on her criminal record but it was removed after she reported it. Nothing has been on since, but they claim they put charges on to harm Angel without anyone knowing it.

Angel found out the City Police had Angel down for a 10-34 Riot and Angel never was in a roit. This and othe police reports show foul play including Timothy Knight and Kalamazoo DHHS for a torture report which leads back to DHHS doing Kalamazoo psychiatric hospital torture and it is noted that in fact DHHS did and does do this. This torture Section 750.85, 18 US Code 2304a puts harm on Angel

and they put her down as a threat to DHHS for her mental state while being tortured. Angel has proof of all these statements showing proof DHHS admits torture to Angel is why she is reacting but DHHS instead puts her down to get rid of her. They put her on Probate and won for a year killing Angel by radiating the entire time.

Angel found out that North Carolina Marine corp base has a law that if anyone has a Criminal sexual conduct gets radiated. If they have a Criminal sexual conduct on record they get tortured and radiated if they use the internet and a phone that has internet. This was not discovered until recently summer 2018. Angel would go to the library and get attacked severely by sexual programs which then would frame Angel and make her get false reports.

Angel does NOT have a CSC and has never been to jail and never was accused FORMALLY for sexual crimes. The only time she SEEN ANYTHING ON PAPER was on the 2007 claim from Stefanie Bennett and Portage PD, Kalamazoo 8<sup>th</sup> District Court, Angel was not at the scene and had no idea of the incident, so she was not guilty. Also, Borgess Hospital Social Worker Cynthia Jubenville had wrongfully wrote down sexual exploitation in 2014 on records. Angel did not know until 2018 after she finally got her records from Borgess. The central registry which list all child abuse including sexual abuse, so they figured they had legal authority to radiate and torture Angel which is execution or murder due to the fact she is innocent and not a sexual absconder.

Angel and did an action with the the Marine Corp to find out how bad this problem is regarding false reports and corruption. The findings is that its really out of control and lethal. They sent phony text action to help make it look legal for them to kill Angel so they could get away with it instead of being prosecuted. Just in case the case denied for appeal that Angel went through in August and September 2018. The government use's false information and hoaxes on a daily basis to put people in the mental facility to then torture them into doing something that will help them prosecute someone who is innocent. In this case they do the actions on Angel to prevent prosecution and prevent themselves from being taken down. They then make a case on bogus claims and eventually kill someone for a made-up story.

Angels other phone number 269-999-3159 has the text messages that show proof of the phony text messages after Angel told the Marine about how they were killing people for joking around about being with a 17-year-old. Angel seen this lady had died after joking around about a 17-year-old. Then you can see what happen on Angels text after the Marine set Angel up with a bogus comment about her raping someone that didn't even exist. The text shows what she was going through directly after. Angel called Portage PD, Allegan County and Michigan Administrative Hearing System with that phone text so when they pulled it they would react, and they started to charged Angel with this crime that she for certain had no part of and it was all made up completely. They put the information in the Kalamazoo psychiatric hospital and then ran her on the programs that torture in that category for rape which for this made up. A made-up bogus text can lead to severe torture and death. After Angel is set up then they can put the corrective programs in to

then cause reasonable doubt. They have done terrorism in many of the actions as noted.

If they were not raping and molesting Angel by programming framing her at the KALAMAZOO PSYCHIATRIC HOSPITAL and other mental places and then placing her on the central registry it may not have caused North Carolina to use lethal actions. This was a conspiracy to commit murder and attempted murder. Borgess hospital and Cynthia Jubenville and DHHS placing Angel on the central registry and lying on record causing Angel to not understand what her rights are will cost Angel her life and has shortened her life severely. Also North Carolina doing the actions to Angel when she does not live in North Carolina this is also illegal they are out of jurisdiction.

North Carolina is the only state that has this law about sex offenders, phones and internet torture and radiation for offenders. That is how Angel figured out Marine Corp Lejeune was the place who was radiating her and doing the horrible actions. The actions that are done are cruel and unusual punishment. The radiation is thought of eminent death and all the while it is happening the mental trauma is horrible. The person begins not to care and they can be dangerous. Certain people if they were really child molesters or sex offenders would do the crime even more because they are dying any ways. This is a botched execution practice because the person will die but when is unknown for each individual. They can tell if the crime has been committed by a court martial or a probe/scope.

Department of Human Services has it noted on the US District Court and Federal District court files that Angel had no criminal charges and no convictions. Angel came back to Michigan last year 2017 and she was under criminal and state charges and she never has been to jail. They prosecuted Angel illegally and did so in an attempt to murder her. Angel checked her record again after reporting the problem and the courts removed the criminal charges only. The civil child abuse charges are still on which are from the State even though they claim Angel had no state charges. They framed her so often by false reports it caused for her to be radiated from the framing each time decreasing her life more.

Angel Bartlett just had another case get denied on the beginning of October 2018 from the Department of Licensing and Regulatory Affairs for the Central Registry and mental illness case with the State of Michigan. Angel got a text message from a marine corp friend and he made a phony text that said Angel raped his sister the phone number was 269-999-3159 and then they attacked Angel at the Kalamazoo psychiatric hospital and the police and courts in Kalamazoo circuit court and Portage Police and possibly Allegan Courts as well. 
