**REHEARING GRANTED ON SUBSTANTIAL GROUND PREVIOUSLY NOT PRESENTED ON Intervening Circumstances beyond Angels control** Allegan County have all learned terrorist ways and have been using them on Angel Bartlett and her family as tactics after they brought in Kamal Saleem. Kamal Saleem and House of State of Michigan case involvement with Allegan City Police AND Allegan County, ON Intervening Circumstances beyond Angels control due to the fact Angel has no attorney and no help from the government all is done by her own investigations. They with held information and did terrorist actions on Angel which has caused more problems that were unnecessary. They use controls on ANGEL that limit her ability and they are forcing the case to great depths to cover their hit they did on Angel and her children. They should not have ever attacked Angel at all. All of the Exhibits still apply. The Supplement can be taken out but the Exhibits and the facts to the case that is all listed are the truth and Angel needs to have the issues resolved and paid in full for terroristic actions and attacks Angel has been through. Also, the peonage they did to her for years. Allegan City Police are being held responsible for the actions and that carries to the Sheriff Department which are all under the several Courts and State. All of the other respondents can give up information on the State and others for exemptions to the case and be dismissed if in fact they were not at fault if this case settles. They have placed educational programs on Angel, or they ordered them is why they went to the school for the meeting in 2012 with Kamal Saleem and David Agema. Mr. Hammer and other mentioned may have been the ones that did the orders for the mental state to hinder Angel, so she had so many issues dealing with her life.

- A. WHY does Child Protective Services and the State and or Courts decide to Kill or execute Angel Bartlett? Has this been resolved? They are trying to say it was all The house of Saud and the laws now. That is not going to be considered as a reason for them not to pay Angel for what they just did.
- B. **IS the only reason that Angel has NOT been able to get off the Central Registry is because the Parents of the adopted kids Lorrain Pope and Steve Oatmen for Diana and Kailey Bartlett and Jeff and Jennifer Wassink for Lance Bartlett?** Because they do not want to and or will not allow Angel to get free because they will not believe Angel will go on without her kids? They keep making sure Angel is held down because they know the next step is Angel filing for visitation. That is not the CASE and in fact Angel must work on her life getting stable before she can do anything else. That fact of visitation should NOT be the reason why Angel is held on the Central Registry only. Angel is NOT a threat to any kid. **IF this is the problem they must be held liable and held accountable for this and must be held on attempted murder.**

- C. Or are these people the ones making sure Angel stays on the Central registry for reasons to hold someone's custody and keep their soul in their custody: Child Protective Services and or CASA Laura Jousma, Betty Weighmink courts Judge Michael Buck, Craig Sewell, Jolene Clearwater, Judith Astle, Robert Kengis, Amy Clapp, Maureen Koch, Bell, and all his other court officials including Dorphine Payne, State of Michigan DHHS, State House and Senate, David Agema and others, Governor Rick Synder Lt. Governor Brian Calley, LARA and or CAIR of MI, or any other including the police such as Rick Hoyer chief of Police in Allegan County.
1. Angel got wrongful feedback in regard to the state, Borgess and others for their defense. And that would be that I'm held by a terrorist unit Isis or Al-Qaeda or the Taliban or some middle eastern military unit or medical military unit.
  - Here's why? At any point somebody can give Angels information or anyone's information to some person in another country or in our country. They can terrorize the person by using medical or military equipment on Angel or anyone. They can bring her in and know all her thoughts hooking her up to Intel and do so at any time.
  - But here is where my understanding comes back to being Borgess and Bronson and the Kalamazoo psychiatric hospital along with the state of Michigan Department of Human Services in the central registry. They may still give information to the House of Saud or some other country but that still was from the State of Michigan. If the State of Michigan did not do this then they would NOT be allowed to do this. They have to have permission. WHY?
  - If a terrorist person or group gets ahold of Angel or ANYONE you contact a higher agency they send out a drone or aerial craft to pick up the demographics of the incoming then they send an execution or whatever type of tactic they want to execute or take down the people that are doing the incoming by their malicious programs or by their malicious Hardware. That's why we have wars randomly in other countries. That's why we have random bomb explosions.

Angel thought she had no issues with international countries at all. Then Angel was sent to write in peace but was abrasive due to the guidance she had from her agent who was allowing for the security to seek out Saudi Arabia for the human's rights activist that was honored by the State department for her courage. Angel then had an attack and lost her case with the State for the central registry. This was all a set up to bring out more information, but it is dangerous and a security risk she could have lost her life and lost years of her life by the radiation that she sustained from the attack. If she did NOT write to Saudi Arabia, she would not have remembered the attack when she was told she was intended to marry Prince Muhammad. Angel was informed about the past Prince Muhammad Bin intending to marry event back in 2012. At this exact time Angel had no idea who any Prince Muhammad was and sought out years ago but never found him. At that exact time when she looked online in 2012, Angel was hit, or she called it nuked by a force and was held. It felt as if her soul was disintegrated from her body. Angel called 911 and spoke with the Michigan State Police who then directed her to the FBI and then she was told to go to the ER if she felt like she got gutted. At that time, she packed up the kids and went to her mom's house and then told her mom and then was going to go to the ER and instead drove around and felt a little better. It was not long after Angel was attacked again and again and again, and everyone thought she was just crazy. Allegan County and LARA did this to Angel because they were being sued by the State David Agema and the House of Saud Royal Commission Kamal Saleem. Allegan claims this was all the house of Saud doing this to Angel and everyone in a terrorist attack and they can say this to put it on them, but Angel knows they have done this to her for a long time and they did this to her aunt Cheryl Foster and did the same tactics. This was just more severe. They figured Angel had big people and could be a threat because she knew people in the cartel or in high end places so they had to put her down

as a terrorist after they got all of the suspects, they thought who may help her in custody. Angel thinks they got Kamal Saleem involved as a hit man or someone to deal with the issues as far as the people who were being looked into as a possible threat who protected Angel in the past who were gang members or related to the Cartel. All of them had to be turned against her and this then put Angel in more danger. They did all this mess to Angel and it was all wrongful. Angel is certain there was no marriage intending to Prince Muhammad this was all a diversion to get Angel down and to get someone else to blame on everything. They had to have a reason to attack Angel in the way they did. They framed her for a death penalty of drug trafficking all to hold her for peonage for years. All of the State is held responsible for the actions they did, and Angel is sure there are more people involved we just need to settle on the case issues being presented from past issues. They did not need to do this to Angels family, and they did not need to do this to Angel.

## 2. WHY DID THIS HAPPEN? And More information.

- a. Allegan County was in the middle of a case with the House of Saud and the State of Michigan David Agema case no. 1:12-cv-417. David Agema invited Kamal Saleem to the Allegan high school to do a presentation and it was cancelled. Allegan Chief of police Rick Hoyer and Josh Morgan, CAIR MI which is LARA WHO I ALSO HAVE IN THIS CASE, ALLEGAN SCHOOLS which is where the educational programs come in play with my problems. All the court house and all of Allegan County were either doing a hit on Angel and used this as a way to communicate and pass money back and forth or it was a several other problems.
- b. Allegan defense is they are all mentally ill and being used as a three way to come after Angel and everyone she knows to kill her for hate crime reasons on both sides House of Saud and Allegan County. They know what they are doing so this is a lame excuse. If this was the house of Saud we would have taken them down or went to war with them. Kamal Saleem is also friends with Mike Pence and the president see exhibit of TWITTER EMAIL FROM PENCE TO SALEEM.
- c. Angel knows Bill Sage was a part of this case he was with the Tea party. They all were using Angel trying to get the laws changed and remap how people think and try to resolve terroristic behaviors.
- d. One argument was that Allegan Police Chief Rick Hoyer was brought in due to the case with the State and Saleem and had done horrible education orders on Angel and also was the ones that framed Angel for the drug trafficking. They had to do something once they got audited. They even tried to say Angel was Rick Hoyers daughter, so they all went after Angel and her family as a part of vengeance or as a counter attack. Angel don't know her real dad. Rick has since tried to put Angel in the mental hospital instead of trying to get her home and help her. Angel knows Rick has done a number of horrible actions to her and her family using her and her family for many years. Ricks defense was Angel was insane or mentally ill and in fact he could be mentally ill and so could all of the county because the house of Saud has mind control and so does the courts so it's all the same. Angel knows what a scope and a probe is Angel knows better on this defense. They can NOT say this was only the house of Saud going after the County and then making them all mental to then go after Angel when they claim she was intended to marry Prince Muhammad.
- e. Angel has had years prior to having been intended to marry or meet some prince. She has been with the monarchy for a while maybe forever. Angel had sovereignty and they were trying to steal it and did steal it to a point. They are using her and forcing certain beliefs in order to get their own way. As long as they have her in custody, they have control over the laws and the nations. By forcing certain areas of problems into Angels life they law change and the issues are

supposed to be resolved. They claim this is why they did this, but Angel is sick of being used more peonage being done.

- f. Angel also knows in 2011 Lorrain Pope went to the Air Force because of the attack from the US District Court and the Cartel indictment with Gabriel Gunn and the hospitals all coming after Angel for Rick Hoyer again back in 2010. They will put this on Kalamazoo and Borgess and Danielle Whaley, but it was all set up by Rick Hoyer and Allegan courts/police.
- Lorrain getting the Air Force involved got the house of Saud involved. Angel had allegations of being ISIS or Al-Qaida and was held by them because not only Gabriel Gunn had Cartel or Columbian drug lords who also are not a problem at this time. Pakistan was mentioned when Gunn came over and that put us at war with Pakistan because Gunn said that Pakistan had the largest amount of opium fields around and the war was all about drugs and that is all it is ever about. Then they said it was Gunn being in with Pakistan that he was ISIS or a middle east terrorist unit. This was all a lie to put Angel down in a real bad place. The other reason is they wanted to put a diversion on the house of Saud and Khalid. Khalid was with the Air Force and by Lorrain going to the Air Force they had to check to see if Angel was held by the middle east and she was not. They still made everyone think this to then put her under. They made everyone think Angel was held by terrorist to then put her in mental health and then attack her to steal her kids and attempt to kill her. Angel also had no issues with Pakistan because she was friends with the person at the store who was helping her spiritually not as a terrorist, but they still may have been picked up and destroyed because anyone who holds people without permission from the United States can get attacked unless they know the person. Angel knows all they had to do is do a security check and see where the transmissions were coming from and if they would not stop the people would be taken down or they would do an air strike if it was violent or dangerous terrorist.
- They also stated that Angel had Rick Hoyer and Lorrain Pope fighting over her rights and the Air Force and the house of Saud were with the House and Senate on one side and then the LARA DHHS and the police were on the other side but that too is not right because Lorrain was on both sides then so it was all them doing the job of stealing my kids and trying to kill me or get rid of me because of the State of Michigan, Borgess, State worker Shannon Wagoner, Angel Hopkins CMH, Kalamazoo courts, all of the people involved. Each do orders over and over again to take down.
- The other argument was they all were working together to kill Angel and put her in the middle to destroy her every inch of her appeals and case. All made up story's manipulation and mind control along with educational programs from the ALLEGAN HIGH SCHOOL that is why Bill Sage was meeting with Kamal Saleem. They had to put Angel under with educational programs and the MENTAL CONFINEMENT in order to make sure Angel was going to not be able to get back up. Angel having mental confinement she was unable to reread the things that she wrote this then allowing for the hacking and the false testimony which is tampering with evidence but also a homicidal attack from the government that was attacking her.
- They countered this and said it was all the middle east because Angel has had bad feelings about the kids who the adults in the middle east marry. Angel feels it is wrong for the middle east men to marry children. Angel wondered if the House of Saud did not like Angel because she was not going to be alright with Saudi Arabia and how they marry young children. Angel would not be able to marry Prince Muhammad, so they had to try to enforce her to change her mind. They may have put the child abuse on Angel to show her how it feels for a person to come to the US and have the STATE put this program on them because they married a young person and then moved to the US. This is NOT Angels fault and if this was the case this was a hate crime

against Angel from the middle east. Angel was being framed for child abuse on every account and many of the people said it was the house and the other said it was the Marine Corp and courts because of the house. Angel said it was the house and the county and they do this action together it is just what they have done, and it must be corrected. Allegan Courts said it was something they were wanting to change and then they started framing Angel as a child abuser. This is wrongful and should not have happen. Angel has lost years of her life. Allegan County and the State all of the State must be held accountable for their actions. They should not have allowed for anyone to be in her files destroying her in any way for any reason including the Marine Corp. They could have in fact went after the Marine Corp but instead helped the marine Corp damage and destroy Angel in every way.

- They even tried to say Kamal Saleem was a terrorist still and had terrorist in his mental state and infatuated Allegan County Police system got Angels information took it out and realized it was the reason for the 911 attacks. All due to Big Boy and Allegan Courts placing no sale orders on Angel. AGAIN, this goes back to Allegan County and them not understanding it don't matter who has Angels information they could have picked up the person by their location and destroyed the target so that is no excuse. Kamal Saleem would not have terrorist in his profile any more than the President would have because they can pick up anyone if they really wanted to. This is not the problem. The only people who have been terrorizing Angel is the police and also the State and if the State or government and courts allowed the house of Saud in to do their dirty work then they too are to blame.
- g. Angel has no issues with International people to have anybody do any international terrorism if she does it is the State of Michigan and government allowing this to take place. EVEN IF THERE WAS IT COULD BE RESOLVED THERE IS NO NEED FOR IT TO GO ON FOR 7 YEARS AS IT HAS FROM THE UNITED STATES GOVERNMENT. Even if Prince Muhammad Bin Salman Al-Saud and Angel are fighting which they are not in a good position right now Angel don't like that they made Angel delusional. Angel knows they put delusional disorder on her for this case and that alone is not right. Angel is also not happy with the State department for allowing the delusional disorder to be placed either. Angel must get the case resolved not only for her but for her family. As it seems it is a bad move on their part also because it has destroyed any idea of peace or getting the problems corrected. Angel feels they used her as a three way to go after Allegan County or vice versa or both.

Angel feels they made Allegan County be put under in court, so Allegan then put Angel down. This way both sides putting her at war for all the issues underlaying. Angel had no idea where she was at. It was a diversion tactic so no one could identify where she was at. Angel feels the State House used Angel to get the laws changed and to try to blanket all Muslims with the issues Angel has brought to the courts. The Muslims needed it, but it is now only causing more of an issue then it was supposed to help. They now made it so we could be really close to a war. Again, another statement that is false the house of Saud said they came with the House David Agama to defend Angel and the issues she was so called held by the middle east government which is all false claims. They did defend Angel for the educational and money cut off programs that have been placed. They also defended Angel on the drug trafficking framing and the slavery peonage that Allegan County has done to Angel. They must still want her to be held down for some reason. They still put her down and up in different ways to get their problems resolved but who cares about what they just all did to her. They made Angel delusional and got the case thrown which kept Angel down again.

Angel just defended Prince Muhammad Al-Saud and he still made her delusional. They made Angel care about Prince Muhammad only to then make her look like she was stupid or foolish after ordering her there to do peace keeping. The Police put programs on her for this and tried to say she was doing treason which was never the case. Then they put Prince Al-Waleed Bin-Talal on her after he passed away on December 23. They even tried to pass Prince Al-Waleed to Angel and even tried to say his wife came down to dog her out. Then they tried to put more mental illness on her trying to get him after her saying it was all her fault why his dad died, and Angel never reported any information of them except Prince Muhammad and his brother Prince Khalid who is the US Ambassador and with the Air Force. Angel would not do any harm to any of their people. It was wrongful for them to come and make Angel mental for the State house and the County of Allegan this was all wrongful for them to do but that is what they all must have planned the entire time. They all work for the State and that is why they all say is a MUSA event the person who has their kids taken away and they use the House to do their dirty work.

They were killing Angel no one cares what she just went through. Angel was attacked and being slowly executed for 7 years. This is sick to do to anyone. Angel feels it was a tool for defense at this level and was planned out for this specific time to be brought out. They all should have told Angel about all of this many years ago. ALL who are involved need to be charged with withholding evidence. They used this as a tool to bring it out now to only distort the courts to get the case denied. This should not be a reason to have the case not be heard or seen or decided. All the evidence that has been shown still applies.

Angel know it's the system and she know it's the Kalamazoo psychiatric hospital I know it's Borgess and Bronson, Community Mental Health in ALLEGAN AND KALAMAZOO, probate court house terrorizes without a probate order all the time. Angel also knows it's the State. Angel knows how a probe Works in a specific way and they know she didn't do these actions with her physical body or hands or even my mental state and they were in in-plants from somebody else and that would have been the Marine Corps or any other people in the government prosecutors Etc. on top of that these people have to use government satellites for the communication to come through. The mental framing and the constant wrongful trials must stop.

That means that our government is allowing this communication and they're not cutting it off. If I was to go to the mental facility, they would override it so why is it they just don't shut it off they're intentionally requesting the attacks from the international people if there is any besides their own mental illness programming systems. Angel has contacted people to check out every person that she has communication with. Angel said if we have a system that is out of control and is causing people to hack in and use our satellites to torture and manipulate us then the satellites will have to go down. People must go home. This is what I'm dealing with right now but Borgess and Bronson and Kalamazoo Psychiatric Hospital in the state of Michigan and all the other people that are in my responded list are still held responsible. Angel needs to go home. Angel needs to be home from all police and all courts/state and houses. Angels kids need to go home also. HOME free from government holding in systems.

Angel is sick of being used. Angel wants compensation for the actions that have been done and her used time. Angel has lost so much time it's not correct. Angel has no money and is always used. Angel has to fight to stay alive. Also, she will have to get a transplant eventually



and it will cost 500,000. All because of the attacks after she said she would maybe Marry Prince Muhammad. They terrorized her and tried to kill her and get rid of her in every way. This is why they put the hag order on her to make her not pretty. They claim it was a number of people to make Angel ugly because other woman who were jealous. They used this as another excuse of why they did the bad actions to Angel. Angel feels that they report her false to then get her soul in custody and they can use her as long as they have her in custody. As long as Angel is in the ward system she is out internally, and it is a horrible uneasy feeling her soul is not at peace and she will have to be in court fighting this case until it is resolved. A HATE CRIME is worth 250 Million and the central registry is worth 55 million. Wrongful child abuse and attacks on the family is worth much more time that can't be replaced. Lives that are ruined including Angel. Angel was ordered to seek out Saudi Arabia only for them to be used again to place attacks on her and then she was forced to be delusional about Prince Muhammad Bin Salman Al-Saud for him and Mike Pompeo State department to make Angel delusional and get her case denied. They even tried to do the same action again once they realized the case could go for a motion to reconsider. For a short time, no actions were being placed for any meeting or court ship with Al-Saud or anyone when they found out the case was denied.

If there in a ward system, they have no free will with pre-disdains them to bad problems and possibly even Eternal damnation hell because they don't care anymore, and they are forced to do things by the system which makes it so they have no Free Will and it still damages their soul. I know the whole religious factor is hard to deal with but it's what honestly it comes down to. Then there's the fact that Jeff and Jennifer Wassink also need to have this Ward system placed on to them, so they can understand or my son Lance Bartlett who I'm certain they change his name as well. Even if I can't get them back or never get visitation, they still all need to be out of the ward system and so do I. I've been told that they all have been considered Isis and Al Qaeda or some terrorist hold just as I have been. If they were around me and I got put into some terrorist group they would also be put in but I know for a fact that we have technology that picks up any type of transmission and they can determine exactly where it's coming from location and the person would be demolished exterminated executed if they were a terrorist. This is just a fear tactic and they have to understand no one is messing with me except the State of Michigan and the police who also don't really mess with me except to try to make me mental for the cases. NO one has died in the house hold where I lives so far, and it has been since last year in April or maybe even March when I moved in. I am pretty sure no one has died in his family either and Angel calls him. IF they report that Angel is a terrorist or a blood or anything that would be terroristic everyone gets taken out who is near and that is only a tactic to destroy. ANYONE who has reported this should be held accountable for their actions for future calls. They build false cases by false reports and then Angel gets radiated but that too is under control because Angel has the military in her favor.
