Due to extreme financial difficulty, Loss of employment, I was unable to purchase supplies to prepare the Writ of Certiorari for case denied by the Appeals Court in Atlanta, Georgia May 3, 2018, which the date, 90 days from the denial date is August 1st, 2018. I am in need of extension of 60 days to prepare the Writ of Certiorari.

The Appeals Court denied my Petition(s) for Rehearing and Petition(s) for Rehearing En Banc. I feel the case is extremely important for the safety of me and my family, and my rights as a law enforcement employee, and and the safety of the United States Government, inclusive.

In 2003, I performed a very high Act of Achievement for Department of Homeland Security. I was team member Administration Division initiated case against African National individuals whom had processed false U.S. Government Purchase Order against the Special Agent in Charge, Miami to steal high technical equipment from a UPS Delivery driver in Fort Lauderdale, Florida. I was given task to begin record search. The case became criminal, grand jury. The criminals were arrested and deported back to Africa. I was never acknowledged, paid nor anything for processing major part of that case. I was very proud that I was able to help in an important matter, wherein I was experiencing unfair treatment at work. I was never assigned an attorney to help me in the EEOC process. I have been pro se status. I feel I have been unfairly cheated and mistreated my entire work time in Fort Lauderdale Office of Investigations, in U.S. Treasury and Department of Homeland Security status.

The judgment sought to be reviewed is whether my claims have been intentionally overlooked to not give me the justice needed in my case. I feel any coverup of any kind within the Agency against me need clarifying so to never happen again to me nor anyone. This case matter involves United States Supreme Court cases filed by me of recent: 17-6738 and 17-7434, respectively; and very important cases that did not get attention they deserve due to my immediate loss of income from my regular U.S. Government employment: Removal from Federal Employment: U.S. District Court, SD Fl: Case#15-61868-Civ-Dimitrouleas and Religious Harassment: U.S. District Court, SD Fl: Case #15-61793-Civ-Dimitrouleas.
