At 11:00 AM on April 27, 2012, as a US citizen I (Mohsen Khoshmood ) disable man walked into the 1133 Capital Street Housing Authority Headquarters to get an appointment with own case worker in Washington DC to obtain a future appointment with my case manager. I told the security guard I need the appointment from my case worker, and she told me to sign the book, to sit down, and I call them, I sat down. There were 20+ people there before me sitting down. After 30 minutes, all of the previous people were seen, and new ones began to be seen before me, even though I had signed in earlier than them. I stood up and showed the security guards my name in the registration book, and asked them could you can call and remind again, OK "I'm going to call" she said, indicating she would call them. I thanked them and sit down again. After another 30 minutes passed, all of the security guards changed. I approached the desk and told the new guard that I'd been waiting a long time for my case manager. He told me to sit down and that they would call them. I sit down again.

After 5 minutes two officers came out and called me to standing middle of waiting room. They told me to leave. I try to tell them, I'm waiting for my case worker " there attacked me, two officers in front of twenty waiting people and 2 cameras, attacked me, punching me in the stomach, and lifted me under each arm, carrying me out of the room. They punched me two or three more times in the stomach along the way. One of the officers told the other officer to drop me at the stairs. Around that time I rescued my right arm and grasped a stairwell column. The two officers forcefully tried to pull me off the column, yanking and twisting my left arm, and to push me down the stairs. In this process, their violent actions caused me tremendous, overwhelming pain, and to lose the function and use of my left arm as they tried to pull me off the stairwell column. I called "Help! Help!" The pain was too much. At this point I lost consciousness.

According to reports I arrived at a hospital around 6pm. I awoke in the hospital around 7 - 8 pm. I was in the hospital until I was transferred to the jail under the morphine medication. For pain.

A) (police report N: **12057187** , 04/27/2012). After one week again I went the hospital and finally obtained medication. I had lost the use of my left arm. I found out later that my arm was broken. I also did not know why I was in jail. I figured out I was charged with some

On March 28, 2017 again I make the lawsuit for \$200 Million case N. **2017 CA 002026** and case dismiss with out any concern ,case N **2017 CA 2073** dismiss and Appeals , No liberty, no justice , no constitution of law, just racism and discrimination with the system clearly blind.

I think enough is enough from top to bottom has to be change and reorganized the new system for Americans. ## Statement of Case

The facts are on April , 27, 2012 I at approx. 11:00 AM, I Mohsen Khoshmood, as a citizen of the U.S., walked to the HA office at 1133 Capital Street office of headquarter housing authority in Washington DC to request an appointment. At the front desk I asked for an appointment with my case manager. The guard asked me to sign the book and to sit down, and told me they would call them. More than 20 people have been waiting and I sit down more than 30 minutes after 30 minutes I stand up and asked, from security guard and show them my name in the registration book and I told what happened she told we called again I'm going to call, I Thanks them and sit down again after 30 minutes all security guards is changed I point to the security guard I'm waiting long time to my canceler he told me sit down we call them After 5 minutes two officers came out and called me to come over. then told me to leave. I try to tell them I'm waiting for my case worker get the appointment or to call me. At this time two officers in front of 20 people eyes front of 2 cameras, attacked me, punching me in the stomach, and lifted me under each arm, carrying me out of the room. They punched me two or three more times in the stomach along the way. One of the officers told the other officer to drop me at the stairs. Around that time I rescued my right arm and grasped a stairwell column. The two officers forcefully tried to pull me off the column, yanking and twisting my left arm, and to push me down the stairs. In this process, their violent actions caused me tremendous, overwhelming pain, and to lose the function and use of my left arm as they tried to pull me off the stairwell column. I called "Help! Help!" The pain was too much. At this point I lost consciousness.

According to reports I arrived at a hospital around 6pm. I awoke in the hospital the pressure and finally 10:00 PM police report appendix: ( D ) transfer me to the jail. After one week again I got the hospital and get medication. Finally I figure out, I'm charged criminal case and judge Juliet McKenna had been unfair judge and I asked them for justice and discovery and a jury trial. After psychological evaluation, The Judge denied me to get a trial and removed

all my rights under the faire housing act, and dismissed the case (2012 CMD-7290) without any consideration for my broken left hand and suffering from pain. I appealed N.13-CO-611 appendix ( B-3) I applied on 2/11/2013 CA 002329, new complaint and was dismissed on 7/2013 I appealed, On 2013 court dismiss for lack of justice. Appendix (B-4 ), I complaint first to the Mayor and 2nd human right and 3rd risk management of DC appendix (E-1,2,3) before filling a lawsuit. I complained to get the justice, and again dismissed and appealed never got the answer that wrong jurisdiction, on ,2015, 2016 case N. 2016-CA 002286 appendix (B-2 ) even reconsideration is denied in all courts and court system never give me a chance to trail and liberty, All these established with HA and Mayor of DC and president Obama time under the democracy. Justice especially under the Race, discrimination, religious and color we need purpose the court system liberty, constitution of law and Amendment of laws cover the citizens rights for services from government, we have to trust , believe ,value of judgement and value judicial system in this case is negative. I'm still after 21 time this authorities attacked me and destroyed my life, family life, my reputation, my personality, my carrier , My believe and My trust from system and rob or stile all of my document under the president Obama time I believe they are criminal in this case. In 1998 I qualified for Section 8 and 2018 eviction from housing authority for single parent unemployed and my son was in middle school HOD or housing authority take me to the street. I complaint to the court and HA section 8 property (bout denied) on 19100 Harvard Ave. Irvine CA HUD sold the property with out concern my family life I left my sons to get the Washington DC to complaint to section 8 program why there are denied, in El Paso I got accident until one year I had out of my main finally I come back to California to found my son younger one Farsheed Khoshmood until to day missing. I think in 2011 I applied for housing and 2012 I did not get the appointment from my application I had in Housing Authority office and case management wild high with 2 security person front of eyes of 20 people with 2

cameras 2 security guard attack to me and brook my arm and all judges with out any concern dismiss this case. Until to day seems conspiracy in judicial system administration law judge removed all my rights under the constitution of law and all amendment rights and human right laws in this nation with unfair judgement, that is the reason they are removed my rights to get jury trial as a criminal charges. All judges responsible anything happened to me and my family in the future. This is \$200 million lawsuit pain and suffering me and my family which destroyed with housing authorities.

Within the past 17 years, increasing dissatisfaction has been expressed with eviction practices in public low-rent housing projects section 8. During that period, a number of suits have been filed throughout the United States generally challenging the right of a Local Authority to evict a tenant without advising him of the reasons for such eviction from 19100 unit F section HUD property my son was in the middle school that time and court with out any consent. And result of that eviction cost to destroyed my family my life still until to day my son is missing from year 1999.

Pursuant to its general rule making power under HUD of the United States Housing fair I'm waiting to result of this action to transfer to United Nation complain why US destroyed life and family life. Or cover the my damages .




