MS. NICHOLS: Yes, is there any way you can give me Jim Caldwell's number or tell him to go by Aaron Nichols? There's a problem in Burgin.

DISPATCHER: Ann Nichols?

MS. NICHOLS: Aaron Nichols out on Buster Pike behind the barn.

DISPATCHER: Okay, what's the address on Buster; do you know?

MS. NICHOLS: Jim Caldwell knows where it's at. He's been there before. But there's a guy down there that's got a gun.

DISPATCHER: Anybody else there?

MS. NICHOLS: My son is there but – his name is Aaron Nichols. I own the trailer place. He lives in a trailer back there. But Jim Caldwell knows where it's at.

DISPATCHER: What's your phone number?

MS. NICHOLS: 865-2471.

DISPATCHER: All right.

MS. NICHOLS: Okay?

[3] DISPATCHER: Do you know who has the weapon?

MS. NICHOLS: I know my son told him not to bring a – the boy – hold on a minute.

(Cell phone rings.)

MS. NICHOLS: Hello. Shoot. Tommy II Hurst, young boy or something. I don't really know. I'm just hearing bits and pieces. I just woke up. I have to go to work in a little while.

DISPATCHER: All right, I'll send him on out there.

MS. NICHOLS: Hold on. Hold on. What's going on, Aaron? Well, does he have, a gun or what? Well, I done talked to him. Are you still there?

DISPATCHER: Hang on just a moment, ma'am.

MS. NICHOLS: Can you just have –

DISPATCHER: I'm trying to get him en route, ma'am. Hang on just a second.

MS. NICHOLS: Okay, well, I just told Jim, told Jim to come over there. No. Are you there?

DISPATCHER: I'm here.

MS. NICHOLS: Okay, is Jim coming? Are you [4] there? Hello.

DISPATCHER: Ma'am, I'm here. I'm trying to get Mr. Caldwell there, okay.

MS. NICHOLS: Oh, okay.

DISPATCHER: All right, he's en route. Hang on just a second for me, okay?

MS. NICHOLS: Okay, well, I'll talk to Jim. And they're on the way over there. I'm talking to the police department.

MS. NICHOLS: Yes, I'm talking to him on the phone right now. He said he's out there sitting in a vehicle. He's afraid to say anything because –

DISPATCHER: What kind of a vehicle is it? What kind of a vehicle is it, ma'am?

MS. NICHOLS: What kind of a vehicle is it, Aaron? It's a white Toyota 4Runner. He said he was out there and he just – he don't know where he went to. He didn't know if he was around back or what so – all right, I don't know. He had come over there before and he had been –

MS. NICHOLS: Beverly Nichols. I'm his mother. He was just scared. He come over there before

and had a gun and he was scared that he had a gun or something. Are you there?

DISPATCHER: I'm here.

MS. NICHOLS: Okay, he said he doesn't know. He said the truck didn't start up. It wouldn't start. And he didn't know where he went to. He didn't know if he was behind his house or what. All right, Aaron, Aaron –

DISPATCHER: Is it – what kind of gun is it? Is it like a rifle or a small gun?

MS. NICHOLS: He said he didn't know if he had a gun or not. He thought he – they called and told me – his father called me and told me that Tommy was over there and had a gun and got me – they just woke me up. And then I thought well, I better call you all because I don't know what he's up to or what he's doing over there because his dad lives in [6] front, Tommy II Hurst's dad.

DISPATCHER: Okay.

MS. NICHOLS: And they told me that he had a gun back there. And I thought well, I'm not – I can't get over there in time but Jim could. Jim knows what's going on. I think Aaron had talked to Jim before about Tommy II having a gun or something. And my son was scared of him, afraid that he was going to shoot him or something because he wanted to come in and take a shower. And my son wouldn't let him come in to take a shower. I don't know what's going on. Are you there?

DISPATCHER: 157, subject to be in a white Toyota 4Runner, white Toyota 4Runner near the barn.

MALE SPEAKER: It's going to be Tommy Hurst, II, isn't it? That's kind of what I figured.

MALE SPEAKER: We got 29s on him?

MALE SPEAKER: 157, the subject is going to be Tommy Hurst. Tommy Hurst is – possibly has the weapon. It has not been seen. It's just been implied.

MALE SPEAKER: 90, copy. I'm on Cane Run now.

MALE SPEAKER: I'm pretty sure he's a convicted felon. They did not see a weapon on this

occasion but the subject [10] gestured down his crotch like he had a weapon and has brandished a weapon out here in the past.
