This case was tried before a jury in November 2015 with respect to Plaintiff's gender discrimination and retaliation claims under Title VII, 42 U.S.C. § 2000e, *et. seq.* The jury rendered a verdict in favor of Defendant on both of those claims, and Defendant is considered the prevailing party for all purposes with respect to Plaintiff's Title VII claims. Plaintiff's remaining cause of action for age discrimination under the Age Discrimination in Employment Act of 1967

(“ADEA”), 29 U.S.C. §§ 621-634, is set for a bench trial on April 19, 2016.

The parties, by and through their respective attorneys, have agreed to dismiss Plaintiff’s remaining cause of action under the ADEA, with prejudice, and have agreed that each party is to bear their own costs and/or fees with respect to Plaintiff’s age discrimination claim under the ADEA.

Having considered the parties’ Joint Motion and Stipulation, and finding it meritorious, the Court hereby GRANTS the Joint Motion and orders Plaintiff’s age discrimination claim under the ADEA dismissed with prejudice. Accordingly the bench trial date set for April 19, 2016 is VACATED. The Court will enter Judgment on this case as to the remaining claims.
